Marijuana is one of the most widely used substances among pregnant women in the U.S., and pediatricians need to be able to counsel young women about its effects.

A new AAP clinical report recommends that pediatricians advise adolescents and women of childbearing age to abstain from marijuana use while pregnant or breastfeeding due to potential adverse consequences to the fetus, infant or child.

The report *Marijuana Use During Pregnancy and Breastfeeding: Implications for Neonatal and Childhood Outcomes*, from the Committee on Substance Use and Prevention and Section on Breastfeeding, is available at <https://doi.org/10.1542/peds.2018-1889> and is published in the September issue of *Pediatrics*.

Growing influence

Social media tout the use of marijuana for severe nausea associated with pregnancy, and its legalization in some areas may give the false impression that it is safe.

At press time, nonmedical marijuana use was legal in nine states and the District of Columbia for adults 21 years and older. Medical marijuana was legal in 30 states and the district.

Consequently, more women are using or contemplating using marijuana while pregnant and breastfeeding. Recent data show the prevalence of "past month" marijuana use among pregnant women 18-44 years of age increased from 2.4% in 2002 to 3.9% in 2014, with (7.5%) of pregnant 18- to 25-year-olds reporting use. There are no national data on use by pregnant teenagers.

Potential harms

The clinical report discusses how cannabinoids can cross the placenta and affect fetal development, as well as concerns about pregnancy outcomes and long-term consequences for the infant or child exposed to marijuana in utero. The understanding of the endocannabinoid system and its role in the development of neural circuitry early in fetal life also provides theoretical justification for the potential of marijuana substances, particularly tetrahydrocannabinol (THC), to affect neurodevelopment.

Due to ethical and legal constraints, there are no randomized trials of marijuana use during pregnancy and breastfeeding. Consequently, all data are from observational studies. The report summarizes these data, including a

recent meta-analysis to determine the effect of marijuana exposure during pregnancy while controlling for tobacco use and other confounders, such as other drug use.

The authors of the meta-analysis stated that the increasing frequency of marijuana use during pregnancy may play a role in risk for adverse neonatal outcomes. They cautioned, however, that women who use marijuana more frequently also are more likely to use higher amounts of tobacco and other drugs, which could not be accounted for completely in their review.

Two longitudinal studies have followed cohorts of infants prenatally exposed to marijuana through adolescence and early adulthood; these studies were limited in their ability to control for environmental and sociodemographic variables.

Despite the limitations, the observational studies indicate reason for concern, particularly in fetal growth, early neonatal behaviors and long-term neurodevelopmental and behavioral consequences of prenatal exposure to marijuana. Further, these studies were conducted when marijuana had a much lower potency than what is available today. Thus, the adverse consequences of prenatal exposure today may be much greater than what has been reported to date.

Impact on breastfeeding

There are little data on the effect of marijuana use while breastfeeding.

Breastfeeding has numerous health benefits for the mother and the infant, particularly the preterm infant. Limited data show that THC does transfer into human milk, but there is no evidence for the safety or harm of marijuana use during lactation.

Additional concerns are that infants exposed through breastfeeding also may have been exposed during pregnancy and through inhalation of marijuana smoked in their presence.

Recommendations for pediatricians

- Inform adolescents and women of reproductive age about the lack of definitive research. Counsel about concerns regarding potential adverse effects of THC exposure, including passive smoke, on pregnant women and fetal, infant and child development. Include marijuana when discussing the need to abstain from tobacco, alcohol and other drugs during pregnancy.
- Counsel pregnant women who are using marijuana or other cannabinoid-containing products to treat a medical condition, nausea and vomiting during pregnancy — or who are identified during screening as using marijuana — about the lack of safety data and the possible adverse effects of THC on the developing fetus.
- Explain that even where marijuana is legal, pregnant women can be subject to child welfare investigations if they have a positive marijuana screen result.
- Note that data are insufficient to assess the effects on infants who are exposed to maternal marijuana while breastfeeding. Inform women of the potential risk of exposure during lactation and encourage them to abstain from using any marijuana products while breastfeeding.
- Encourage women who never have used marijuana to remain abstinent while pregnant and breastfeeding.
- Work with state/local health departments if legalization of marijuana has occurred or is being considered to help with constructive, nonpunitive policy and education for families.

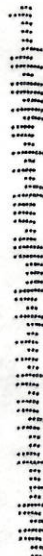

Hi there. My name is Teri Zell. My husband owns Bad Gramm3r in Wasilla. We are in the midst of sending in an application for another store.

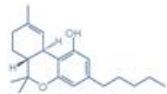

Cannatest has stated that they will not spend the \$100 on a Ethanol Standard unless you, the state agency in charge of regulating this industry, requires them to. This is disgusting to me. This is a massive issue, and it will not be the last you hear of it. Ethanol is the most common solvent used for winterization of the majority forms of cannabis concentrates available on the market. Currently Alaska's regulations do not require Marijuana Testing Facilities to become accredited, they must meeting all of the state regulations for operations. We do have one lab that has become ISO accredited at their own desire.

AMCO currently has a contract out with American Associations for Laboratory Accreditation (A2LA) for review and inspection of our testing facilities to ensure they meet the state requirements. AMCO is not currently soliciting for an accreditation service as it is not required by our current regulations, should our regulations change, AMCO would begin the request for proposal process and accept solicitations from vendors.

Currently two cannabis festival events have been fined for allowing consumption of cannabis at cannabis events. A third event, High Times Cannabis Cup, a 21 and over event, was directed not to allow consumption at their cannabis event. This is due to the interpretation of “public” by AMCO, as indicated in Sec. 17.38.040. “It is unlawful to consume marijuana in public. A person who violates this section is guilty of a violation punishable by a fine of up to \$100.”

Currently there are several definitions of “public”, which AMCO has chosen to interpret as a place a large number of the public has access to. Another definition of “public” is :

public definition: 1. relating to or involving people in general, rather than being limited to a particular group of people

When AS 17.38 came up on the ballot for a public vote of the people, I believe the intent of Sec. 17.38.040 was to prevent people from standing in front of Fred Meyers or Mc Donalds taking it up. That was a reasonable request in the interest of respect for our neighbors and public safety, I believe most people in the state who voted on this ballot measure interpret this intent the same way. However, due to the choice AMCO has made to interpret the word “public”, cannabis events statewide have been targeted and harassed by AMCO to prevent “public” consumption of cannabis. The irony is that High Times beer vendors were able to sell plenty of beer to patrons at the cannabis festival, but no cannabis was allowed to be consumed. Had AMCO chosen a more friendly version of the definition of “public” to enforce, such as “relating to or involving people in general, rather than being limited to a particular group of people”, consumption of cannabis at cannabis events would be perfectly acceptable, as they are a particular group of people. This was a choice.

If the intent of no public consumption is to protect the general public from cannabis, it is likely that those people not interested in using cannabis would not attend a cannabis festival/awards ceremony. So who then is being protected? Are we being protected from ourselves? This would be like attending the Kenai River Beer festival (kids allowed) but not able to purchase or drink beer. It is unacceptable that AMCO has chosen to be hostile towards our cannabis trade shows and events for using a legal product simply because they choose to interpret the word “public” to include private cannabis events.

I feel this is a failure that can be fixed, but those in control are unwilling to fix it. It is wrong to prevent this industry from benefiting from very specific activities, festivals and traditions that have long been practiced. Alaskans have been extremely respectful of the “no public consumption” rule. There has not been one public grouping of 10,000 people smoking in the middle of Main St., as we have seen in every other recreational state on 4/20. We have been good boys and girls, but please recognize the importance of allowing us to enjoy OUR industry traditions in a responsible manner away from the general public.

I very strongly encourage the Marijuana Control Board to offer guidance to enforcement, the director and the legislature if need be, to clarify and enforce the definition of “public” as “relating to or involving people in general, rather than being limited to a particular group of people.” An “Event Permit License” should be created

to allow cannabis events and their patrons the freedom to celebrate cannabis in a specific area for a particular group of people. This would also generate additional revenue to the state in the form of an event permit fee. Please end the discriminatory treatment of our states' cannabis trade shows and licensees.

Eric Vanveen and wife were partners with Aaron in starting Green Leaf, Aaron put himself in control of money and would never let Eric or Cathie have access to financial accounting. COMPLAINT

Connor Nelson, brings this complaint against the defendant GreenLeaf, Inc., and in support thereof, alleges:

I. Introduction.

Connor Nelson is a 10% owner of Greenleaf, Inc, marijuana growing and retail business located in Sitka, Alaska. Greenleaf, Inc. holds two (2) licenses for such operations, License # 10066 and #10067. The Alaska Marijuana Control Board (AMCO) requires all owners to submit a Form MJ-20, Renewal Application Certification in accordance with the renewal schedule. As of the date of this filing, License #10066 and #10067 has an immanently pending renewal deadline, and it is doubtful that Greenleaf, Inc. will make its renewal deadline.

Within the MJ-120, all owners must declare, under penalty of unsworn falsification, that among other things, that the business complies with applicable tax statutes, all ordinances, statutes, laws, and is operating in compliance with the Alaska Labor and Workforce Developments laws and regulations pertaining to employees. Mr. Nelson, as an owner of Greenleaf, Inc. is required to complete the MJ-20 for renewal of the above licenses. However, due to the non-cooperation of Greenleaf, Inc. he is unable to do so.

Beginning in January, 2018 Nelson began requesting business records of Greenleaf, Inc. both orally and in writing. By April 2018, with the federal tax deadline passed, Nelson was forced to file a personal extension on his taxes due to lack of Greenleaf, Inc.'s failure to provide tax information. On May 22, 2018 Nelson retained counsel to assist with books and records, for tax purposes, but also in order to assist with obtaining the requisite information for him to complete the MJ-20.

As of the date of this filing, Greenleaf, Inc. refuses to comply with Alaska's Corporate Law regarding its books and records, annual reporting and financial statements. This failure will likely lead to loss of AMCO licenses for the business, with severe if not fatal consequences for the company.

II. Parties.

1. Connor Nelson is a resident of Sitka, Alaska.
2. Green Leaf, Inc. is a company licensed to do business in the State of Alaska.

III. Jurisdiction and Venue.

3. Jurisdiction and venue are proper in this Court pursuant to AS 22.10.030 and Alaska Rule of Civil Procedure 3, as the First Judicial District is the judicial district in which the claim arose.

IV. **Factual Allegations.**

1. Connor Nelson is a 10% owner of Greenleaf, Inc, marijuana growing and retail business located in Sitka, Alaska.
2. Aaron Bean is a 90% owner of Greenleaf, Inc.
3. Greenleaf, Inc. holds two (2) licenses for such operations, License # 10066 and #10067.
4. The Alaska Marijuana Control Board (AMCO) requires all owners to submit a Form MJ-20, Renewal Application Certification in accordance with the renewal schedule.
5. As of the date of the filing of this lawsuit, License #10066 and #10067 has an immanently pending renewal deadline, and it is doubtful that Greenleaf, Inc. will make its renewal deadline.
6. Within the MJ-120, all owners must declare, under penalty of unsworn falsification, that among other things, that the business complies with applicable tax statues, all ordinances, statutes, laws, and is operating in compliance with the Alaska Labor and Workforce Developments laws and regulations pertaining to employees.
7. Mr. Nelson and Mr. Bean, as owner's of Greenleaf, Inc., are each required to complete the MJ-20 for renewal of the above licenses.
8. Due to the non-cooperation of Mr. Bean to provide access to Greenleaf, Inc.'s books and records, Nelson is unable complete the requisite MJ-20.
9. Beginning in January, 2018, if not sooner, Nelson began requesting business records of Greenleaf, Inc. both orally and in writing.

10. By April 2018, with the federal tax deadline passed, Nelson was forced to file a personal extension on his taxes due to lack of Greenleaf, Inc.'s failure to provide tax information.
11. AS 10.06.430(a) requires a corporation to keep correct and complete books and records of account and minutes of proceedings of its shareholders and board.
12. AS 10.06.430(b) requires that corporation must also keep all books and records of account available for inspection and copying at the registered office or principal place of business in the state.
13. On May 22, 2018 Nelson, through counsel, requested, in writing, the above information stating with reasonable particularity, the purpose of such request, namely to compete taxes and comply with AMCO deadlines.
14. As of the date of this filing, Greenleaf, Inc. refuses to comply with Alaska's Corporate Law regarding its books and records, annual reporting and financial statements.
15. AS 10.06.430(c) states that an officer or agent who, or a corporation that, refuses to allow a shareholder is liable to the shareholder for a penalty in the amount of 10 percent of the value of the shares owned by the shareholder or \$5,000, whichever is greater, in addition to other damages or remedy given the shareholder by law.
16. This failure will likely lead to loss of Greenleaf, Inc.'s AMCO licenses for the business, with severe if not fatal consequences for Nelson and the company.

V. First Cause of Action: Breach of AS 10.06.430.

15. Nelson incorporates herein the allegations of paragraphs 1 through 16, by this reference.

15. Greenleaf, Inc., or its officer Aaron Bean, has refused to allow shareholder Nelson to examine and make copies from its books and records of account, minutes, and record of shareholders in violation of AS 10.06.430(b).

16. Pursuant to AS 10.06.430(c), Greenleaf, Inc., or its officer Aaron Bean, is liable to Nelson for a penalty in the amount of 10 percent of the value of the shares owned by Nelson or \$5,000, whichever is greater, in addition to other damages or remedy given to Nelson pursuant to law.

WHEREFORE, Nelson is entitled to judgment against the defendant for:

- A. An order compelling the production for examination by Nelson of the books and records of account, minutes, and record of shareholders of Greenleaf, Inc.;
- B. A Penalty in the amount of 10 percent of the value of the shares owned by Nelson or \$5,000, whichever is greater;
- C. reasonable cost, attorney fees, and
- D. such other and further relief as the Court deems just and proper.

Pursuant to AS 10.06.433 and AS 10.06.430, Mr. Nelson, as a shareholder of Greenleaf, Inc. is requesting a 2017 annual report, the income statement for 2017, a three-month (3) income statement for the quarter ending in March 2018, a balance sheet of the corporation as of March 2018. In addition, this request will serve as an advance request that on August 1, a month six (6) month income statement for the quarter ending in June 2018, a balance sheet of the corporation as of June 2018 be delivered.

In addition, Greenleaf, Inc. has failed to make available its books and records of account, for inspection or copying in violation of AS 10.06.430, and has made no attempt to do so. Please be advised that Mr. Nelson will be pursuing damages to the fullest extent of the law.
