Comments were presented by the following: Dr. Mary Loeb, Sunshine Community Health Center; Dr. Tom Hunt, Anchorage Neighborhood Health Center; Robin Wahto, RN, UAA Allied Health Programs; Don Balasa, American Association of Medical Assistants via telephone; Shelley Hughes, Primary Care Association, letter and in person; Summer Cutting, ANP; Dianne Tarrant, ANP, President, Alaska Nurse Practitioner Association; Jo Ann Sullivan, RN; and Dr. Laura Jones, LaTouche Pediatrics, LLC. While all the above testimony was in favor of removal of 12 AAC 44.970 (13), one notable exception was Jo Anne Sullivan, RN, who testified that she was present for a portion of the 10 years of deliberations leading up to the delegation regulations 12 AAC 950-970; she notes that the problems leading up to the promulgation of these regulations were very serious breeches to public safety, through the indiscriminant use of UAPs to perform complex nursing duties that require nursing judgment.

Written materials reviewed during this time included: comments obtained by Denise Ekstrom during informal interviews with area NPs; a summary of the Board of Nursing position, written by Catherine Giessel, MS, RN, ANP, FAANP on June 10, 2008 in response to questions coming to the Board office; a summary of recent National Council of State Boards of Nursing workshop on UAPs in Chicago, IL; Standards and Guidelines for MA education programs from the Commission on Accreditation of Allied Health Education Programs; North Dakota Rules 54-07-05-01 through -10 and 54-07-08-01; email communication to the Board office from Christine Ersland, CPNP.

The Alaska Vocational and Technical Education College (AVTEC) did not meet the 80% cumulative annual pass rate for

first-time takers of the NCLEX-PN examination as required in 12 AAC 44.055. The Board of Nursing issued a letter of concern to the program, requiring the program to submit to the Board a report that (1) analyzes the factors that are believed to be contributing to the low pass rate; and (2) sets out the program's plan to achieve at least an 80% cumulative annual pass rate in the future.

The letter received from J. Kennan Casteel, RN, PhD, AVTEC LPN Program coordinator, was reviewed. A discussion by the Board resulted in the need of a concrete outline as to:

- specify measurable objectives to be instituted by the program
- specific dates when these objectives will be met
- name of the person held accountable for the changes
- a written response to the Board by September 15, 2008.

The Board directs Dr. Sanders to send a letter to Dr. Casteel, addressing the above concerns.
