

12 I, Karen Oyao, voluntarily surrender Alaska Board of Pharmacy license #2369, which  
13 was first issued to me on August 30, 2007 and has an expiration date of June 30, 2016.

14  
15 I am permanently surrendering my license at this time with the understanding that the  
16 Division of Corporations, Business and Professional Licensing has an open investigation under  
17 case number 2014-002048 on behalf of the Alaska State Board of Pharmacy (Board), concerning  
18 an investigation conducted against me by Fred Meyer. I was terminated by Fred Meyer after  
19 video surveillance showed me on May 25, 2014, May 28, 2014, July 9, 2014, July 14, 2014 and  
20 July 17, 2014 concealing narcotics in my clothing, a subsequent audit confirmed the items were  
21 missing from inventory. I declined to be interviewed about this matter.

23 I understand as a result of this surrender, I cannot practice as a Pharmacist Technician in  
24 the State of Alaska and will not be able to do so until I have the approval of the Alaska State  
25 Board of Pharmacy.

27 I am surrendering my license of my own free will and no promises or threats have been  
28 made to me by anyone to make me sign this document.


