As Mr. Saxby was getting ready to sign off, Ms. Cintra asked the Board and Mr. Saxby for the purposes of obtaining information for applicants applying for unit certification examinations under the new regulation (12 AAC 75.112). Can staff request that affidavits be completed by a wildlife biologist, law enforcement officers (state and federal), or by three individuals who can attest/certify that the applicant has experience in the unit for which they are applying for certification. This information would be used to confirm 60-days experience instead of accepting photographs and receipts. Ms. Cintra informed the Board that the affidavits/certifications would be similar to the affidavits in the class-A assistant guide application packet.

The Board directed staff to use an affidavit/certification for the purposes of obtaining 60days of in field experience.

### Item 4. Board GMU Exam Waiver Response Kevin Saxby, AAG

The Board reviewed the information provided by Mr. Saxby. The Board had a very brief discussion and were very happy that the regulations had been signed and would take effect in time for the June 29, 2007 unit certification examination.

### Item 5. Game Management Unit 8 Boundary Changes

The Board had a brief discussion regarding the length of time it would take to complete the public notice portion and get the boundaries changed. Mr. Johnson suggested that the Board conduct the final adoption via teleconference. Ms. Cintra informed the Board that the public notice must be posted for a minimum of 30-days to allow for public comment to be received. Once the comment period had closed, the comments and any other submitted documentation could be sent to the Board via mail or e-mail for the Board to vote on and adopt. The Board informed Ms. Cintra that a mail vote would be fine for this item.

## On a motion duly made by Leif Wilson, seconded by Richard Rohrer, and approved unanimously, it was

RESOLVED to public notice the boundary changes to 08-27, 08-28, and 08-30 as reflected in the March 2007 meeting minutes.

Mr. Rohrer asked Mr. Saxby if there was a quicker way to make boundary changes. Mr. Saxby informed the Board that boundary changes must be public noticed. Mr. Rohrer requested Ms. Cintra to add time to discuss boundary changes on the December 2007 agenda.

### Item 6. December 2006 Board Adopted Regulations

The Board reviewed the revised version of 12 AAC 75.110(c), 12 AAC 75.110(d), 12 AAC 75.110(f), 12 AAC 75.112(a)(2)(D), 12 AAC 75.117, 12 AAC 75.145, 12 AAC 75.205, 12 AAC 75.210(a), 12 AAC 75.210(b), 12 AAC 75.265, 12 AAC 75.340(a)(2)(D), 12 AAC 75.395, 12 AAC 75.400(a), and 12 AAC 75.920.

Mr. Rohrer stated that he felt 12 AAC 75.205(a)(2) was quite strict and that disciplinary actions should be the same for transporters. Mr. Brown and Mr. Wilson agreed with Mr. Rohrer. Mr. Johnson stated that he felt the regulation should be adopted and that the Board could make amendments, if after a period of time there were any problems.

## On a motion duly made by Richard Rohrer, seconded by Colin Brown, and approved unanimously, it was

# RESOLVED to amend 12 AAC 75.205(2) by adding a period, removing "if the", and removing (A) and (B). The amended regulation will read, "(a)(2) may discipline the registered guide-outfitter under AS 08.54.710(a)(2)."

Staff informed the Board that the word "may" allows the Board discretion on disciplinary actions whereas if the wording read "shall" the Board would be in a position where they would have to take disciplinary action. The word "may" gives the Board more leniency.

After a brief discussion Mr. Rohrer withdrew his amendment.

### On a motion duly made by Leif Wilson, seconded by Bob Mumford, and approved unanimously, it was

RESOLVED to public notice all regulations under Item 6; 12 AAC 75.110(c), 12 AAC 75.110(d), 12 AAC 75.110(f), 12 AAC 75.112(a)(2)(D), 12 AAC 75.117, 12 AAC 75.145, 12 AAC 75.205, 12 AAC 75.210(a), 12 AAC 75.210(b), 12 AAC 75.265, 12 AAC 75.340(a)(2)(D), 12 AAC 75.395, 12 AAC 75.400(a), and 12 AAC 75.920 (see regulations attached to end of minutes).

### Item 7. March 2006 Public Noticed Regulations

The Board reviewed the proposed regulations. The Board wanted to take more time to discuss the regulations. Ms. Roccodero informed the Board that they could take more time in discussion of the regulations, however 12 AAC 75.460 and 12 AAC 75.900 should be adopted as soon as possible as many licensees are trying to add species to their licenses and this is a renewal year.

Mr. Johnson stated that he was fine with adopting all the regulations in the packet. Mr. Wilson informed the Board that at its March 2007 meeting 12 AAC 75.925 should have been removed. The Board agreed with Mr. Wilson.

### On a motion duly made by Richard Rohrer, seconded by Ted Spraker, and approved unanimously, it was

RESOLVED to amend 12 AAC 75.230(e) line two by removing "at least". The amended line two will read, "...register for and conduct big game services in a portion of one additional guide use..."

On a motion duly made by Richard Rohrer, seconded by Ted Spraker, and approved unanimously, it was

RESOLVED to amend 12 AAC 75.460(b)(2) by removing "a" and making hunt plural. The amended (b)(2) will read, "an affidavit signed by the applicant certifying that the applicant has been involved in a minimum of three harvests on guided hunts for each listed species."

### Item 9. <u>Review of Guide-Outfitter Application with Fish and Wildlife Violation Report</u>

Mr. Mumford volunteered to review enforcement issues with staff as he is working with enforcement officers. Mr. Johnson thanked Mr. Mumford and noted that he is the liaison with enforcement officers.

Mr. Johnson polled to Board for any objections in processing the application for licensure for Aaron Lief Christiansen as a registered guide-outfitter. Hearing none, Mr. Johnson directed staff to process the application.

Mr. Wilson informed the Board that he had received a letter from the Federal Aviation Administration regarding transporter and guiding issues concerning the requirements for a license issued through the FAA. Mr. Wilson asked if the Board would like a copy. The Board requested that Mr. Wilson fax the letter to staff for forwarding.

The Board adjourned the meeting at 10:23 a.m.
