Agenda Item 2 – Regulations

The first agenda item is review of the Board's current regulation project, which has completed public notice. There was one comment received pertaining to the changes. The comment voiced a concern pertaining to the change to 12 AAC 68.300(d)(2), adding a provision for an employed veterinary technician to provide care under remote direction from their employing veterinarian.

Discussion ensued regarding the concern of maintaining the proper level of supervision of the veterinary technician by the employing veterinarian and veterinary technicians practicing beyond the scope of their license while at the same time addressing the issue of providing some level of care in a remote location where there is no established veterinary practice. They determined if such practices come to light, the Board can re-visit the issue and remedy by repealing the provision.

Discussion was held whereby the Board paid special attention to the cost to private persons of the regulatory action being taken and determined there would be no costs incurred.

On a motion duly made by Dr. Eastman, seconded by Dr. Rose and approved unanimously by roll-call vote, it was

RESOLVED to adopt changes to 12 AAC 68.230, 12 AAC 68.300, 12 AAC 68.310, 12 AAC 68.900.
