On a motion duly made by Massie, seconded by Lushin and carried unanimously, it was RESOLVED that the agenda was approved

RESOLVED to approve the minutes.

On a motion duly made by Massie, seconded by Lushin and carried unanimously, it was

RESOLVED to accept the consent agreement for case #0421-08-006

Being ahead of schedule the board decided to address the license reinstatement of Rose Earwood. Ms Earwood esthetician license has been lapsed for more than three years. She is required by regulation to take a written and practical test in order to reinstate the license. She wrote a letter to the board asking them to waive this requirement. The board cannot waive its own regulations.

RESOLVED to deny the license reinstatement of Rose Earwood unless she passes the written and practical Esthetician tests.

Richard Caulfield gave the background and an update on the TVC Cosmetology Pilot Program.

Presented the course outline that was submitted when the school application was submitted. Received a letter stating that the practicals that were performed at the campus could not be could not be counted as they were not in compliance with the regulation. Stated the letter said it was a new interpretation of the regulation. Would like to request three things:

- That the practical operations already submitted to the board for Jan Jun 2008 be accepted by the board.
- That the program be able to continue as it has performing practicals at the campus
- A regulatory change of 12 AAC 09.127 (b)(2)

Ms. Lynch: The practicals performed at the TVC center are not done on the public. Students perform them on mannequins or each other.

Ms. Conley: Disagrees with Mr. Caulfield characterization of the letter that was sent to him as a new interpretation of 12AAC 09.127(b) (2). It was always there. It went unnoticed until now when students are already into the program. We are addressing it as the regulation was written. It is up to the board to accept/not accept the practical operations.

On a motion duly made by Massie, seconded by Sherman and carried unanimously, it was

RESOLVED to accept the practical operations recorded on the January – June 2008 monthly reports for students enrolled in the TVC Cosmetology Pilot Program

The board went on to discuss changing 12AAC 09.127(b) (2):

Caulfield regulation change needs to clarify the difference between practicals performed on mannequins and those on the public. Needs to allow practicals to be counted when performed at the TVC center, this will allow the students to prepared before they go to the partner salons to work.

Colleen: If the regulation is not changed by January first the college will not be able to count practicals performed at the TVC campus on monthly reports.

Ms. Conley explained that there was an avenue for an emergency change of regulations. She did not have the regulation with her at the moment. It would allow for a shortened time frame. There is a set criterion for determining what an emergency is. She was not sure if it would qualify.

Kim Striker explained the board needs to make an argument to why they think it is an emergency.

The board went on to discuss the meaning of practical operations and if there was any other avenue the school could go through that may not require a regulation change. None could be found.

On a motion duly made by Massie, seconded by Lushin and carried unanimously, it was

RESOLVED to change regulation 12AAC 09.127 (b) (2) to read:

"practical training on members of the public must be performed in a shop licensed under AS 08.13.120 and 12AAC 09.110. For purposes of the regulation, a member of the public does not include mannequins or students register in the college's cosmetology program.

The board requests that this regulation change be an emergency project for the following reasons:

- For the protection of the public, the regulation is being changed to specify where students my perform operations on the public and to define who the public is.
- When the school license was approved the regulation was in place. It was approved even though the curriculum was not in compliance with the current regulation. We have identified an oversight in the application process. The change needs to be made so the college will be in compliance with the curriculum that they have in place now when they start their January 2010 semester.
- New student starting in January 2010 could be delayed and Federal Student Loans could be impacted if the regulation isn't changed to bring the college into compliance by January 2010.

Susan Winton, Investigator for the Dental Board joined the discussion. She explained that Malls and Salons state wide are performing teeth bleaching. An applicant who does not pass all required subjects of all sections of the examination within three years after the date the examination was first administered to the applicant shall retake and pass all required subjects of all sections, including the subjects and sections previously pass, to qualify for licensure. <u>Examinations must be taken</u> <u>at least one per year, in the three year period.</u>

On a motion duly made by Lushin, seconded by Massie and carried unanimously, it was

RESOLVED to change 12 AAC 09.110 (a) (7) to read "...documentation that within 90 days of the date that the application was submitted to the department,....) On a motion duly made by Massie, seconded by Hernley and carried unanimously, it was

RESOLVED to move all the above regulation changes to public

- 2) Recommend Legislature change AS 08.13.010 (a) to read "....7 members appointed by the governor." In the following make-up:

- i) One person licensed as a barber
- ii) One person licensed as a hairdresser
- iii) One person licensed as an esthetician
- iv) One person licensed as a manicurist
- v) One person licensed as a body piercer
- vi) One person licensed as a tattoo and permanent cosmetic color
- vii)One public member
- 3) Recommend raising hours to be licensed as a manicurist to 350 hours.
- 4) Recommend separating Tattooing and Permanent Cosmetic Coloring into two separate licenses.
