By authority of AS 08.01.070 (2) and AS 08.62.030, and in compliance with the provisions of AS 44.62, Article 6, a scheduled teleconference meeting of the Board of Marine Pilots was held on June 17, 1994.

MONDAY, JUNE 6, 1994

Call to Order

0900 Meeting was called to order by Captain Klepper. All Members were present constituting a quorum. Also present was Dan Twohig, Marine Pilot Coordinator.

On a motion made by Mr. Springer, seconded by Capt. O'Hara and carried unanimously, it was

RESOLVED to enter executive session under the authority of AS 44.62.310(c)(5) to discuss the Region 1 local knowledge exam.

1020 The meeting was reconvened in open session.

Comments were made by Captain Klepper regarding the board's deliberations on the questions contained in the Region 1 local knowledge examination. He stated that each and every question on the examination was considered for appropriateness.

Several motions were made by different board members concerning the format for grading the examinations and for reconsideration of each question on the exam as discussed in executive session.

On a motion made by Mr. Watt, seconded by Mr. Springer and carried unanimously, it was

RESOLVED to grade the examination based on the total number of Questions.

On a motion made by Mr. Springer, seconded by Ms. Bumgardner and carried unanimously, it was

RESOLVED to drop questions # 8, 20, 34, 52, 55, and 96 from the Region 1 local knowledge examination.

On a motion made by, Mr. Watt and seconded by Mr. Springer and carried unanimously, it was

RESOLVED to rescore the examinations based on 98 questions removing the dropped questions that both candidate's missed from the pool of scoreable questions.

On a motion made by Mr. Watt, seconded by Ms. Bumgardner and carried unanimously, it was

RESOLVED to rescind the motion striking questions from the examination.

On a motion made by Mr. Watt, seconded by Mr. Springer and carried unanimously it was

RESOLVED to strike questions # 8, 20, and 96.

On a motion made by Mr. Springer, seconded by Mr. Watt and carried 3 YES, 1 NO, and 1 abstention it was

RESOLVED to rescind the method of scoring decided on before.

On a motion made by Mr. Springer, seconded by Mr. Watt and carried 3 YES, 1 NO, and 1 abstention it was

RESOLVED to strike question # 52 from the Region 1, Local Knowledge exam and rescore based on 97 questions.


The marine pilot Coordinator announced the results of the rescored exams:

Captain Picton	81.45%	FAIL


Adjourn
