> Correspondence – Captain O'Hara explained the letter from Pacific Pilotage Authority Canada was a request to the Alaska Board for support of pilot accommodation standards. He noted he was not aware of any problems in Region Two. Captain Gurry, President of Southeast AK Pilots Association (SEAPA) responded to questions from the Board and explained their association did negotiate accommodations with each cruise company individually and yes, they had experienced problems.

The Board took no action.

Regional Pilot Authority Meeting – Captain O'Hara reported that he and the MPC attended the regional pilot authority meeting in Vancouver, BC on December 7 and 8, 2010 by teleconference. The MPC explained the meeting centered around discussion for common safety issues. Captain O'Hara explained the previous meeting by this group had been driven by the Cosco Busan incident

Rate Filings – The Chairman explained the rate filings represented four total, with one outstanding objection. He opened the floor to public comment.

Ms. Tesar, representing ASA, commented on the objection for the proposed Region Two LNG rate and confirmed it had been withdrawn. She also explained an agreement had been reached on the Region One Dry Cargo rate and a letter of withdrawal for the objection was forthcoming.
