Agenda Item - Establishment Regulations / Legislative Strategy

Whereas FBI and local law enforcement expressed concern regarding sex trafficking in the massage establishment industry, and currently there exists no regulations governing such establishments, now therefore be it resolved that we amend 08.61.020 (2) to add " (C) massage therapy establishments." (Unanimously resolved at 905AM)

The board further strategized how to accomplish this in the discussion that ensued.

Jun Maiquis then joined to follow up with the board on their continuing education regulation project and was available to answer questions regarding massage establishment regulations the board is considering.

Upon a motion made by Ron Gibbs and seconded by David Edwards-Smith, with unanimous approval, It was RESOLVED to adopt part 12AAC79.210(d)(2) to include "regionally or nationally accredited institution of higher education; a course, seminar workshop, or other program through that institution must be approved by the board as directly related to the skills and knowledge required for the practice of massage therapy, and includes a bloodborne pathogens and universal precautions course under (C) of this section; or (3) local, state or national professional organization that serves the massage therapy profession, including (A) Associated Bodywork and Massage Professionals; (B) the American Massage Therapy Association; (C) the Federation of State Massage Therapy Boards; and (D) the National Certification Board for Therapeutic Massage and Bodywork. 10:11AM

Upon a motion made by Ron Gibbs and seconded by Shirley Nelson, with unanimous approval, It was RESOLVED to recess until 1030, 1013AM

Upon a motion made by Ron Gibbs and seconded by Traci Gilmour,
