- Occupational Therapy Dry Needling

  - Initial regulation language written as part of Scope of Practice work group and approved at 6/16/2023 board meeting. Language revised 12/4/2023.
  - Opening Questionnaire completed 12/4/2023
  - Proposed language approved for public comment subject to approval by Department of Law at 2/16/2024 board meeting
  - Board modified vote 04/04/2024 proposed language to be reviewed by the board w/Department of Law modifications before going out to public comment
- Physical Therapy Dry Needling
  - Project adopted at 6/16/2023 board meeting + language approved by the board 06/16/2023.
  - o Regulation language written as part of Scope of Practice work group
  - o Regulation language revised 03/19/2024
  - o Opening Questionnaire completed 03/19/2024

Status update - PT Dry Needling language approved by the Physical Therapy and Occupational Therapy at 04-04-2024 board meeting. Motion included both PT and OT Dry Needling draft language to be reviewed by Board with any Department of Law modifications prior to going out for public comment.

- A. 12 AAC 54.040(c) (h) and 12 AAC 54.110 (4) per 08.84.032(2) revision for removal of PT 6-month Internship for Foreign-Educated applicants revamp "supervised field work" definition for physical therapy
  - Project adopted at 11/17/2023 board meeting

- Draft regulation language need to be written
- Opening Questionnaire needs to be completed
- Item tabled for PT input

Item remains tabled for physical therapy input.

- B. **12 AAC 54.600 (3)** cleanup language regarding verification of applicant's licensure status specifically "one of which must indicate a current license in good standing".
  - Project adopted at 2/16/2024 board meeting.
  - Regulation language drafted needs to be reviewed
  - Opening Questionnaire drafted needs to be reviewed
  - 12 AAC 54.600 Regulations project language DRAFT (003) 04052024.pdf

Reviewed draft language completed by Rebecca Dean. Discussed including language in 12 AAC 54.030 Physical Therapy Licensure by Examination that would set a time limit on ability to apply by examination similar to language that already exists for occupational therapy. Need additional input from physical therapy on appropriate time period. Because board is also considering modifying 12 AAC 54.600(6)(C), would need inclusion of completion of 150 hour internship Regulations Project to finalize this regulations project.

Rebecca Dean motioned to accept drafted language for 12 AAC 54.600 (3) as submitted with the following modifications:

- "OR" to be added to 6B after semicolon of 12 AAC 54.6XX Application for Occupational Therapy Licensure by Credentials
- Pending discussion of including additional language in 12 AAC 54.030 limiting time period for taking National Physical Therapy Examination (NPTE) similar to language of 12 AAC 54.6XX(4) Requirements for Occupational Therapy License by Examination "during the 24 months immediately before the date the application is received by the department".
- Completion of secondary Regulations Project modification of 12 AAC 54.6XX(6)(C) "satisfactorily completed an internship of 150 hours approved by the board."

Motion seconded by Lindsey Hill. All in favor; none opposed. Motion carries unanimously.

Staff to correct 12 AAC 54.6XX Application for Occupational Therapy Licensure by Credentials - add "OR" to 6B after semicolon

- C. **12 AAC 54.600(6)(c) + 12 AAC 54.950(e)** 150-hour Internship requirement for Initial applicants and new license whose original license lapsed for 5 years or more revamp definition of internship for these sections
  - Project adopted at 2/16/2024 board meeting
  - Draft regulation language needs to be written
  - Opening Questionnaire needs to be completed
    - Committee collected re-entry examples utilized by other states for review.

Discussion - Objective - Redefine 12 AAC 54.100(5)(C) and 12 AAC 54.600(6)(C) and 12 AAC 54.950(e) pathways for therapists re-entering the workforce and replace 150-hour internship with a combination of education and supervised service delivery. AOTA Guidelines for Reentry Into the Field of Occupational Therapy reviewed.

"Present evidence to the department that the applicant was actively registered or licensed as a therapist in another state during the 3 year period in good standing" - possibly use language similar to MI (ii) OT example - clarifying working history needed within active license status.

No exemption from licensure exists within AS 08.84.150 for physical therapy. Could define as "supervised field work program" specifically for this regulation only for occupational therapy to comply with AS 08.84.150(b)(1) license exemption. Need to check on possibility of temporary permit being issued for this requirement.

Motion made by Rebecca Dean to pend work on this regulations project for further review of options on redefining pathways and temporary permit possibility. Motion seconded by Lindsey Hill. All in favor; none opposed.

- D. Supervision of Students during clinical internship of PT/PTA and OT/OTA aka "supervised fieldwork" prior to graduation
  - Project adopted at 2/16/2024 board meeting
  - Draft regulation language needs to be written
  - Opening Questionnaire needs to be completed
  - Concern to be discussed at next meeting if regulations are written, would language be dictating standards for educational institutions since new definitions of "supervised field work" put it under CAPTE or ACOTE standards? New definitions of "supervised field work" effective 03/26/2024:
    - 12 AAC 54.070. Supervised field work. As used in AS 08.84.030(a)(1), "supervised field work" means the clinical education experience portion of a CAPTE-accredited educational program to be completed under the supervision of a licensed physical therapist.
    - 12 AAC 54.620. Supervised field work. As used in AS 08.84.030(b)(1), 08.84.032(b)(2), and 08.84.150(b)(1) "supervised field work" means the portion of an ACOTE-accredited professional occupational therapy education program to be completed by an applicant under the supervision of a licensed occupational therapist.
      - o Committee will collect data from other states on supervision of students

Rebecca Dean motioned to recommend to Board to dismiss Regulations Project on Supervision of Students during clinical internship for PT/PTA and OT/OTA - aka "supervised fieldwork" prior to graduation. Conflict exists if regulations written, as board would be dictating standards for educational institutions since new definitions of "supervised field work" put it under CAPTE or ACOTE standards per 12 AAC 54.070 and 12 AAC 54.620. Motion seconded by Lindsey Hill. All in favor; none opposed. Motion to recommend dismissal of regulations project passes unanimously.

## E. Examiner Suggestions

 Add "Space Force" to 12 AAC 54.435 (e) and 12 AAC 54.725 (e) Exemption from CE Requirements for Active-Duty Military Service

- 12 AAC 54.500(b) + 54.805 Posting of a license or permit update language
- 12 AAC 54.660 Temporary Military Courtesy License does not require Verification of License must be sent "directly to the Division from the source" like all other application types
- 12 AAC 54.710(h) why do we require photocopy of the front and back of the applicant's current NBCOT certificate. Accept Electronic wallet card or NBCOT Primary source online OTR/COTA verification?
- 12 AAC 54.920 Change of Name or address Repeal and default to Centralized licensing regulation 12 AAC 02.900 instead. 54.920 requires notarized copy of a legal document for name change which is more than 12 AAC 02.900.

## Examiner Suggestions Draft 04-06-2024.pdf

Draft language reviewed. Discussion of 12 AAC 54.500(b) and 54.805 - what if person does not have a business or physical location - where do they post? Website? Traveler - wallet card? Need to research possible language solutions.

Rebecca Dean motioned to accept the following proposed draft regulation language changes as submitted and reviewed and add to an existing regulations project to be forward to the board for recommendation:

- 12 AAC 54.435 (e) and 12 AAC 54.725 (e) Exemption from CE Requirements for Active Duty Military Service - Add Space Force as branch of service included in exemption
- 12 AAC 54.660 (4) Temporary Military Courtesy License standardize language so Verification of License must be sent "directly to the Division from the source" like all other application types
- 12 AAC 54.710(h) modernize language to include all forms of verification of current NBCOT OTR/COTA certification
- 12 AAC 54.920 (b) Change of Name or address modify name change to Centralized licensing regulation 12 AAC 02.900 instead

Pend 12 AAC 54.500(b) + 54.805 - Posting of a license or permit - for update of language pending research of solutions for travelers who may not have an actual business location or only a website.

Motion seconded by Lindsey Hill. All in favor; none opposed. Motion to accept proposed draft regulation language changes for 12 AAC 54.435(e); 12 AAC 54.725(e); 12 AAC 54.660(4); 12 AAC 54.710(h); and 12 AAC 54.920(b) for recommendation to the board passes unanimously.
