<p>Administrative Supervision</p>	<p>Supervision--what is supervision?</p>	<p>National Council of State Boards of Nursing defines supervision as the provision of guidance or direction, oversight, evaluation and follow-up by the licensed nurse for the accomplishment of a nursing task delegated to nursing assistive personnel. This definition goes on to define Direct Supervision as involving the presence of the licensed nurse who is working with other nurses and/or nursing assistive personnel to observe and direct the assistant's activities. The proximity of this supervision is such that immediate intervention is possible if problems occur. Indirect Supervision occurs when the licensed nurse is not present and supervision is provided by other than direct observation of the nurses and/or nursing assistive personnel. Just as it is a class B misdemeanor for person to employ "as a nurse" a person who is not licensed to practice nursing (AS 08.68.340(a)(3), it is similarly illegal for a person to use in connection with the person's name a designation that implies the person is a licensed nurse unless the person actually is licensed (AS 08.68.340(a)(4).
