UPON THE PETITION OF THE STATE OF ALASKA, DEPARTMENT OF COMMERCE, COMMUNITY AND ECONOMIC DEVELOPMENT, DIVISION OF CORPORATIONS, BUSINESS AND PROFESSIONAL LICENSING ("DIVISION") FOR SUMMARY SUSPENSION OF PHYSICAL THERAPIST LICENSE \#PHYP2639, AND UPON EVIDENCE PRESENTED BY THE DIVISION, THE ALASKA PHYSICAL AND OCCUPATIONAL THERAPY ("BOARD") FINDS THAT DR. JEFFREY C. FULTZ POSES A CLEAR AND IMMEDIATE DANGERTO THE PUBLIC HEALTH AND SAFETY IF HE CONTINUES TO PRACTICE AS A PHYSICALTHERAPIST.
