penalties. AS 21.27.440(a) provides that "in addition to any other penalties

~-

provided by law, a person that the director determines under AS 21.06.170-21.06.240 has violated the provisions of this chapter is subject to (1) a civil penalty equal to the compensation promised, paid, or to be paid, directly or indirectly, to a person in regard to each violation; (2) either a civil penalty of not more than \$10,000 for each violation or a civil penalty of not more than \$25,000 for each violation if the director determines that the person willfully violated the provisions of this chapter; and (3) denial, nonrenewal, suspension, or revocation of a license." The director has the latitude to impose civil penalties against a person who has violated Alaska's insurance laws.

- B. **RUFFER** further agrees to pay the civil penalty in the amount of \$2,449.68 for activity that occurred prior to the reinstatement of his license with \$1,224 suspended. The unsuspended portion of \$1,224 must be received by the Division within one year of the signature finalizing this agreement.
- C. In the event **RUFFER** is found to have violations of the Alaska insurance laws during the next two years, the suspended portion of the penalty of \$1,224 referenced in section II. B. will be reinstated. **RUFFER** also will be subject to any and all sanctions authorized by the insurance laws including imposition of additional penalties regarding any such violation.
- D. By signing this agreement, RUFFER understands and agrees that any failure to comply with the terms of this agreement will be grounds to revoke, suspend, or non-renew Alaska license number 3001291112.
- E. **RUFFER** understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
