ACCUSATION & ORDER OF REVOCATION

- On or about August 23rd, 2022, the Alaska Department of Commerce,
 Community and Economic Development, Division of Insurance
 (Division) issued a resident Insurance Producer license, license number
 3002104403, to engage in the business of insurance to KITTY C
 CRAFT (CRAFT) domiciled in the State of Alaska.
- 2. On or about August 18th, 2022, a fingerprint card for CRAFT was delivered to the Division in support of the Insurance Producer application. This card was forwarded to and then returned by the Department of Public Safety for the quality and characteristics being too low for processing in October of 2022.

- 3. On November 8th, 2022, correspondence was provided to CRAFT indicating that the fingerprint card was rejected by the Department of Public Safety for "the quality of characteristics are too low to be used," and "multiple candidates were found" and was unable to be processed. The Division also requested for CRAFT to submit new fingerprint card within 15 days. No response was received by the Division.
- 4. On April 7th, 2023, a second correspondence was provided to CRAFT informing that a new fingerprint card had not been received by the Division, and failure to provide fingerprint cards for a background check under Alaska Statute (AS) 21.27.040(e) may result in administrative action or loss of the license. CRAFT did not respond to this contact attempt.
- 5. Pursuant to AS 21.27.040 which states that "(f) If, through inaction, an applicant fails to complete the application process, the applicant's application filed with the director under (a) of this section is considered withdrawn..."
- 6. The Division is revoking the Insurance Producer license for violation of AS 21.27.040(e), which states in part that, "(e) As part of the application required by (a) of this section, a resident applicant shall furnish to the director a full set of fingerprints and the fees required by the Department of Public Safety under AS 12.62.160 for criminal justice information and a national criminal history record check so that the director may obtain criminal justice information as provided under AS 12.62 about

the applicant. The director shall submit the completed fingerprint card and fees to the Department of Public Safety for a report of criminal justice information under AS 12.62 and a national criminal history record check under AS 12.62.400."

7. The Division is revoking CRAFT's license pursuant to AS 21.27.410(a)(2) which states that "(a) The director may deny issuance of or not renew a license or may suspend or revoke a license issued under this chapter for any of the following: (2) a violation or participation in a violation of a provision of this title;"

IT IS HEREBY ORDERED, under the provisions of AS 21.27.410, that CRAFT's Insurance Producer license 3002104403 is REVOKED for a period of one year.
