TO: ALL RESIDENT AND NONRESIDENT SURPLUS LINES BROKERS LICENSED IN THE STATE OF ALASKA AND OTHER INTERESTED PARTIES

RE: LINE CODES FOR SURPLUS LINES TRANSACTION REPORTS

Effective June 11, 2006, the codes listed in 3 AAC 25.090(b)(3) are repealed. Beginning June 11, 2006, the below-listed line codes that are currently in use in the National Association of Insurance Commissioners (NAIC) Annual Statement blank for property and casualty insurers are to be used in surplus lines transaction reports and monthly premium summary reports required under AS 21.34.170(a) and 3 AAC 25.090. Use these codes to identify the type of insurance reported.


- (a) fire (Code 1)
- (b) allied lines (Code 2)
- (c) farmowners multiple peril (Code 3)
- (d) homeowners multiple peril (Code 4)
- (e) commercial multiple peril (Code 5)
- (f) mortgage guaranty (Code 6)
- (g) ocean marine (Code 8)
- (h) inland marine (Code 9)
- (i) financial guaranty (Code 10)
- (j) medical malpractice – occurrence (Code 11.1)
- (k) medical malpractice – claims-made (Code 11.2)
- (l) earthquake (Code 12)
- (m) group accident and health (Code 13)
- (n) credit accident and health (group and individual) (Code 14)
- (o) other accident and health (Code 15)
- (p) workers' compensation (Code 16) **Note: Workers' compensation requires compliance with AS 21.34.030 and includes USL&H and Jones Act coverages.**
- (q) other liability – occurrence (Code 17.1)
- (r) other liability – claims-made (Code 17.2)
- (s) products liability – occurrence (Code 18.1)
- (t) products liability – claims-made (Code 18.2)
- (u) private passenger auto liability (Code 19.2)
- (v) commercial auto liability (Code 19.4)
- (w) auto physical damage (Code 21)

- (x) aircraft (all perils) (Code 22)
- (y) fidelity (Code 23)
- (z) surety (Code 24)
- (aa) burglary and theft (Code 26)
- (bb) boiler and machinery (Code 27)
- (cc) credit (Code 28)
- (dd) other lines of business (Code 33) **Note: If you use this code, you must explain the type of coverage on the report.**

If there is a change to these codes, the division will issue a bulletin reflecting the changes.
