TO: ALL INSURANCE PRODUCERS AND SURPLUS LINES BROKERS, RESIDENT AND NONRESIDENT, LICENSED IN THE STATE OF ALASKA, AND OTHER INTERESTED PARTIES

RE: ELIGIBLE SURPLUS LINES INSURERS IN THE STATE OF ALASKA

Effective July 21, 2011, the Nonadmitted and Reinsurance Reform Act of 2010 (NRRA) applies to the eligibility requirements Alaska may impose on a company to be an eligible nonadmitted insurer. A company will be removed from the listing if it does not meet all of the domestic state and NRRA requirements. Under the authority of AS 21.34.050, I am issuing the attached list of eligible surplus lines insurers. You may check the status of any company at any time on our website at www.commerce.state.ak.us/insurance by clicking the Alaska Division of Insurance Company Search link, which is updated daily.

Alaska has changed the company statuses. The three new status types for companies are:

- White Listed: foreign companies that meet domestic state requirements and NRRA requirements.
- **IID Listed:** Alien companies that are listed on the NAIC Quarterly Listing of Alien Insurers.
- **Listing Approved:** Alien companies that are not listed on the IID quarterly listing but are approved in Alaska.

Alien insurers that are listed on the Quarterly Listing of Alien Insurers maintained by the NAIC will not be part of the Alaska eligible list of insurers, however, alien insurers are eligible to write insurance on an unauthorized basis in Alaska if they are on the Quarterly Listing of Alien Insurers. Alien insurers that are not listed on the NAIC Quarterly Listing of Alien Insurers and want to write business in Alaska must apply for approval as stated in AS 21.34.040 to be listed on the eligible surplus lines insurer list.

Publishing this eligible list does not place any liability on the State of Alaska, Division of Insurance. The Division of Insurance reserves the right to remove a listing of any company if it does not meet the domestic state and federal requirements.
