TO: ALL SURPLUS LINES INSURERS AND INSURANCE PRODUCERS AND SURPLUS LINES BROKERS LICENSED IN THE STATE OF ALASKA AND OTHER INTERESTED PARTIES

RE: ELIGIBLE SURPLUS LINES INSURERS IN THE STATE OF ALASKA

Effective July 21, 2011, the Non-admitted and Reinsurance Reform Act of 2010 (NRRA) identified the eligibility requirements Alaska may impose on a company to be an eligible surplus lines insurer. An insurer will be removed from the list if it does not meet all of the NRRA and domestic state requirements. Foreign surplus lines insurers must provide Alaska with a current copy of the domicile state's certificate of authority or compliance annually. Under the authority of AS 21.34.050, I am issuing the attached list of eligible surplus lines insurers. You may check the status of any insurer at any time at https://sbs-ak.naic.org/Lion-Web/jsp/sbsreports/CompanySearchLookup.jsp.

The three statuses Alaska uses to identify eligible surplus lines insurers are:

- White Listed: Foreign companies that meet the NRRA and domestic state requirements.
- IID Listed: Alien companies that are on the NAIC's Quarterly Listing of Alien Insurers.
- Listing Approved: Alien companies that are not on the NAIC's Quarterly Listing of Alien Insurers but are approved by Alaska.

All alien insurers that are on the NAIC's Quarterly Listing of Alien Insurers are eligible to write non-admitted business in the State of Alaska. This list is available on our website at http://commerce.alaska.gov/web/ins/SurplusLines.aspx.

Alien insurers that are not on the NAIC's Quarterly Listing of Alien Insurers and want to write business in Alaska must apply for approval as stated in AS 21.34.040 to be an eligible surplus lines insurer.

Publishing this eligible list does not place any liability on the State of Alaska, Division of Insurance.
