ORDER OF REVOCATION

1. On or about September 28th, 2021, the Alaska Department of Commerce, Community and Economic Development, Division of Insurance (division) issued a Trainee Independent Adjuster License to transact the business of insurance to **RIDER INGALLS**, domiciled in the State of Alaska.
2. On September 28th, 2021, the division sent correspondence to **RIDER INGALLS** informing him of the Trainee Adjuster Exam Requirements of Sec. 21.27.840 (c)(1).
3. On January 28, 2022, the division sent a letter to **RIDER INGALLS** to notify him that he did not complete the four-month exam requirement

1 for maintaining his Trainee Independent Adjuster License as required by
2 AS 21.27.840 (c). The letter advised **RIDER INGALLS** that if he failed
3 to request cancellation of his license it would result in the revocation of
4 his license by our office under AS 21.27.840 (c) and he would no longer
5 qualify for the Trainee Independent Adjuster license.

7 **4. RIDER INGALLS** had 7 days within receipt of this correspondence to
8 respond to the division. To date no response has been received.
9

10 **5.** Sec. 21.27.840 (C)(1) dictates, “the director shall revoke a trainee independent
11 adjuster license unless the individual has not later than four months after the effective
12 date of the trainee adjuster license, complied with the independent adjuster licensing
13 requirements of AS 21.27.060 concerning the insurance laws and regulations of this
14 state.”

16 **IT IS HEREBY ORDERED**, under the provisions of AS 21.27.840 that **RIDER**
17 **INGALLS** Trainee Adjuster License # 3001550708 is revoked for failure to complete the
18 four-month exam requirements.
