I am pleased to submit to you the annual report of the Alaska Division of Insurance, Department of Commerce, Community, and Economic Development, in accordance with AS 21.06.110. This 75th Annual Report covers calendar year 2012 and fiscal year ending June 30, 2013.

The Division of Insurance provides the regulatory framework for insurance industry operations in Alaska and impacts consumers, agents, and insurance companies alike. The mission of the Division is to regulate the insurance industry to protect Alaskan consumers. The division carries out this mission by developing, interpreting and enforcing insurance statutes and regulations. The experienced and dedicated staff of the division strive to ensure that the insurance market functions effectively for Alaskan consumers and encourages a diverse and competitive marketplace for the insurance industry.

The insurance industry faces challenges today, both nationally and in Alaska. Historically, the insurance industry in the United States has been regulated almost exclusively by individual state governments. The Dodd-Frank Act of 2010 created the Federal Insurance Office (FIO). A report released by FIO in 2013 on the modernization of insurance in the United States questioned whether insurance should continue to be regulated by individual states. Interpretation and implementation of the Patient Protection and Affordable Care Act (PPACA) has necessitated, and will continue to necessitate, significant amounts of resources and coordination between states and the Federal Government. The creation of the Office of Consumer Information and Insurance Oversight brings the appearance of increased federal incursion into state regulation of insurance. International accounting systems are being discussed and the statutory accounting used in the United States is being challenged. Changes made at the federal level could have significant impacts to insurance regulation in Alaska.

Locally, we continue to face the challenges of being a large state with a small population. However, we have seen the entry of new companies into the Alaska market in recent years, and there are new products being offered in various lines of coverage, ranging from workers' compensation and contractor's general liability insurance to homeowner's and life/health insurance. The amount of insurance premiums written in Alaska has risen from \$2.9 billion in calendar

year 2008 to over \$3.3 billion in calendar year 2012. In addition, the number of licensees in Alaska has increased dramatically over the last few years, indicating that the market is becoming more competitive.

Due to the challenges facing state-based insurance regulation, it is imperative that the division continue to be involved in the committees, task forces, and working groups associated with the National Association of Insurance Commissioners (NAIC). The division works with regulators from other states on various issues ranging from actuarial analysis and non-admitted insurance tax allocation to agent licensing and state accreditation. In addition, Alaska participates in multi-state financial examinations and market analysis. Alaska currently holds the Vice-Chair of the American Indian and Alaska Native Liaison Committee. The mission of the NAIC/American Indian and Alaska Native Liaison Committee is to provide a forum for ongoing dialogue between NAIC Members and the American Indian and Alaska Native communities concerning insurance issues of common interest. Through national involvement we are able to communicate issues that impact Alaskans and provide input into the policymaking decisions of the national organization.

The Alaska Division of Insurance is proud of the accomplishments of staff and the positive effects the division has on consumers and the insurance industry. We appreciate the support we receive from the administration, the department, and the legislature. We pledge to continue our efforts to ensure that the Alaska insurance market functions in the best interest of Alaskans.

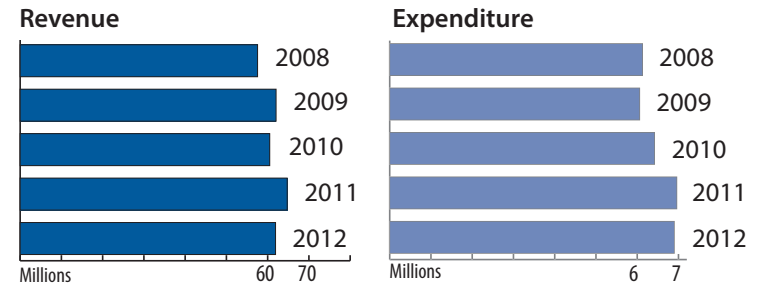

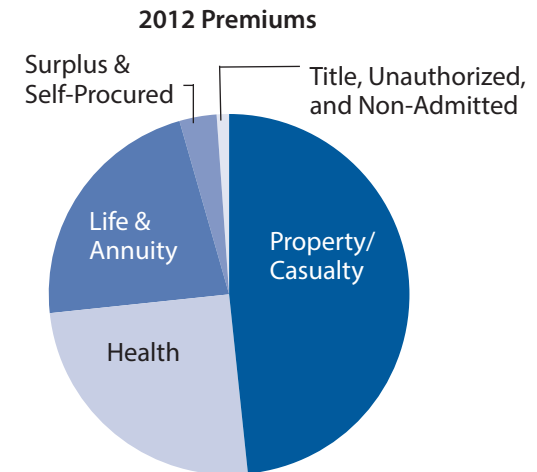

Disciplinary Orders FY 2013 (Each of the following is a Stipulated Agreement and Order, except D 12-01 as indicated.)

D 13-07 Apollo MT, LLC (Apollo) and Eric L. Stirling (Dr. Stirling)

Signed June 25, 2013. Apollo is an Alaska Limited Liability company, entity number 114985. Apollo also holds Alaska insurance producer license number 77004. Dr. Stirling is the president of Apollo and holds Alaska insurance producer license number 77005. Under the above-referenced licenses, Apollo and Dr. Stirling sell insurance policies that are underwritten by the Unified Life Insurance Company. Apollo and Dr. Stirling marketed an association membership program which operated under the name of Medical Transport Association, Apollo Medi Trans, or AMT (hereinafter collectively referred to as (MTA)). The division reviewed available MTA membership program information and determined that the MTA membership program is insurance and that MTA had been transacting insurance in Alaska without a certificate of authority as required under AS 21.09.010. By transacting insurance without a certificate of authority as required by law, Apollo and Dr. Stirling have violated AS 21.36.360. Under the terms of the agreement, Dr. Stirling and Apollo and its affiliates or representatives will immediately cease offering or marketing the emergency membership program in Alaska. Apollo and Dr. Stirling agree that Apollo's website and any other website or any other means that may solicit or reference MTA memberships, including any advertising or promotional material accessible by Alaska consumers will make clear that Apollo's MTA membership program is not available in Alaska. Apollo and Dr. Stirling also agree that neither they nor Apollo's affiliates or representatives will offer a new membership program in any form in Alaska and if Dr. Stirling or Apollo or any affiliate or representative of Apollo desires to develop another membership program in any form in the future, Apollo or Dr. Stirling will notify the division and provide evidence that the program is in compliance with Alaska laws before implementing such a program in Alaska. Apollo and Dr. Stirling also agree to terminate all existing membership agreements and refund all membership fees paid by Alaska residents. Apollo and Dr. Stirling agree to pay a civil penalty under AS 21.36.910 in the amount of \$20,000, with \$15,000 suspended. The unsuspended portion of the penalty is payable three months from the date Apollo and Dr. Stirling are notified that the director has signed the order approving this agreement.

D 13-06 Larissa M. Boswell

Signed April 4, 2013. On or about July 20, 2012, the division first issued a nonresident individual adjuster license to Ms. Boswell, under license number 104896. Ms. Boswell submitted an application to renew her adjuster license in December 2012. In October 2012, the division received information from the National Insurance Producer Registry's (NIPR) Attachments Warehouse regarding disciplinary action taken by the Minnesota Department of Employment and Economic Development indicating Ms. Boswell was found guilty of Unemployment Insurance Benefit Fraud. Both the State of Washington and the State of Minnesota conditioned Ms. Boswell's adjuster license in their respective state on her remaining current with her payment agreement with Minnesota regarding the Insurance Benefit Fraud disciplinary action. The division renewed Ms. Boswell's nonresident individual adjuster license and conditioned the license on Ms. Boswell remaining in good standing in her home state of Minnesota. If Ms. Boswell's Minnesota license becomes inactive or is revoked, Ms. Boswell's Alaska adjuster license will be immediately revoked without further action. Ms. Boswell is required to remain current in her payments under her payment plan with the Minnesota Department of Employment and Economic Development and must provide the division with quarterly statements that her payments have been paid timely, or that the amount owed is otherwise paid in full.

D 13-05 Pamela J. Cookman

Signed March 8, 2013. On October 5, 1990, the division first issued an insurance producer license to Pamela J. Cookman under license number 6378. Ms. Cookman's license was due to expire on October 10, 2013 and was in active status on February 11, 2013 when Ms. Cookman pled guilty to one count of Criminal Use of a Computer under AS 11.46.740(a)(1)(D), a class C felony (3 AN-12-5038Cr.). Under the agreement, Ms. Cookman agrees the conduct for which she was convicted would constitute a violation of AS 21.27.410(a)(8), agrees to have her license revoked, and agrees to not work in the business of insurance in any capacity during her court imposed 30-month probationary period.

D 13-04 York Risk Services Group, Inc. (York)

Signed March 19, 2013 for unlicensed activity that occurred during the time York's employee Brandi J. Bueto was not appropriately licensed. York agrees to pay a civil penalty under AS 21.27.440 in the amount of \$4,104.39, with \$2,000 suspended. The unsuspended portion of the penalty is payable at

the time York is notified that the director has signed the order approving this agreement.

D 13-03 Brandi J. Bueto

Signed March 19, 2013. On April 27, 2012, the division notified Ms. Bueto that her insurance adjuster license had lapsed for failure to renew. On May 4, 2012, the division received application requirements necessary to reinstate Ms. Bueto's license. The division reinstated her license effective June 23, 2012. Ms. Bueto agrees to pay a civil penalty under AS 21.27.440 of \$7,827.76 for the unlicensed activity that occurred between April 27, 2012 and May 17, 2012, with \$6,000 suspended. The unsuspended portion of the penalty is payable at the time Ms. Bueto is notified that the director has signed the order approving this agreement.

D 13-02 Griffin MacLean, Inc. (Griffin)

Signed February 28, 2013 for unlicensed activity that occurred during the time Griffin's employee Robert L. Tobeck was not appropriately licensed. Griffin agrees to pay a civil penalty under AS 21.27.440 in the amount of \$27,597.75, with \$17,000 suspended. The unsuspended portion of the penalty is payable within three months from the time Griffin is notified that the director has signed the order approving this agreement.

D 13-01 Robert L. Tobeck

Signed February 5, 2013. On March 9, 2012, the division notified Mr. Tobeck that his insurance producer license had lapsed for failure to renew. On September 6, 2012, the division received application requirements necessary to reinstate Mr. Tobeck's license. The division reinstated his license effective October 4, 2012. Mr. Tobeck agrees to pay a civil penalty under AS 21.27.440 of \$25,000 for the unlicensed activity that occurred between March 9, 2012 and October 3, 2012, with \$15,000 suspended. The unsuspended portion of the penalty is payable within three months from the time Mr. Tobeck is notified that the director has signed the order approving this agreement.

D 12-17 Wesley N. Yoder

Signed December 14, 2012. On April 22, 2011, the division notified Mr. Yoder that his insurance producer license had lapsed for failure to renew. On January 11, 2012, the division received application requirements necessary to reinstate Mr. Yoder's license. The division reinstated his license effective February 8, 2012. Mr. Yoder agrees to pay a civil penalty under AS 21.27.440 of \$1,000 for the unlicensed activity that occurred between April 14, 2011 and January 26, 2012, with \$500 suspended. The unsuspended portion of the penalty is payable at the time Mr. Yoder is notified that the director has signed the order approving this agreement.

D 12-16 Safeware, The Insurance Agency, Inc. (Safeware)

Signed October 24, 2012. On May 14, 2011, the division notified Safeware that the firm's compliance officer license had lapsed for nonrenewal and that the firm was not authorized to transact insurance in Alaska without a licensed compliance officer. Although the division received notification of a new compliance officer in December 2011, the firm's license renewal application submitted in February 2012 was incomplete and the firm's license lapsed on February 24, 2012. All requirements necessary to reinstate the license were received and the division reinstated Safeware's license effective April 16, 2012. Safeware agrees to pay a civil penalty under AS 21.27.440 in the amount of \$5,031 for the unlicensed activity that occurred between May 14, 2011 and December 19, 2011, with \$2,500 suspended. The unsuspended portion of the penalty is payable at the time Safeware is notified that the director has signed the order approving this agreement.

D 12-15 Erin B. Novotny

Signed October 19, 2012. On or about April 27, 2012, Ms. Novotny submitted to the division an application for an insurance producer license. As Ms. Novotny's application was complete and her answers on the application did not indicate any reason not to issue her a license, the division issued license number 102826, effective April 27, 2012. Subsequently, the division received a criminal history report that revealed a misdemeanor conviction against Ms. Novotny in 2004 that had not been disclosed on the application. Ms. Novotny's failure to report the conviction is a violation of AS 21.27.020 and 21.27.410. Ms. Novotny agrees to pay a civil penalty under AS 21.27.440 in the amount of \$500, with \$250 suspended. The civil penalty is payable at the time Ms. Novotny is notified that the director has signed the order approving this agreement.

Disciplinary Orders FY 2013 (Each of the following is a Stipulated Agreement and Order, except D 12-01 as indicated.)

D 12-14 AmWINS Insurance Brokerage of CA, LLC (AmWINS)

Signed August 31, 2012. Under AS 21.06.130, on March 12, through March 16, 2012, the division performed a limited and targeted premium tax audit of AmWINS covering the period of January 1, 2010 through December 31, 2011. The audit report identified 60 violations of AS 21.34 that are within the control of AmWINS to correct in order to comply with Alaska insurance laws. The violations of AS 21.34 subject AmWINS to civil penalties under AS 21.34.230. AmWINS agrees to pay a civil penalty under AS 21.34.230 in the amount of \$20,000, with \$10,000 suspended. The unsuspended portion of the penalty is payable within three months from the time that AmWINS is notified that the director has signed the order approving this agreement.

D12-13 Swett & Crawford Corporation (S&C)

Signed August 23, 2012, for unlicensed activity that occurred during the time S&C's employee Mary E. Glines was not appropriately licensed. S&C agrees to pay a civil penalty under AS 21.27.440 in the amount of \$40,957, with \$20,000 suspended. The unsuspended portion of the penalty is payable at the time S&C is notified that the director has signed the order approving this agreement.

D12-12 Mary E. Glines

Signed August 23, 2012, for unlicensed activity. Ms. Glines agrees to pay a civil penalty under AS 21.27.440 in the amount of \$17,550 for the unlicensed activity that occurred between March 19, 2009 and April 4, 2012, with \$9,000 suspended. The unsuspended portion of the penalty is payable at the time Ms. Glines is notified that the director has signed the order approving the agreement.

D12-11 Brown & Brown of Washington, Inc. (Brown)

Signed August 31, 2012. Under AS 21.06.130, on September 26 and 27, 2011, the division performed a limited and targeted premium tax audit of Brown covering the period of January 1, 2009 through December 31, 2010. The audit report identified 34 violations of AS 21.34 that are within the control of Brown to correct in order to comply with Alaska insurance laws. The violations of AS 21.34 subject Brown to civil penalties under AS 21.34.230. Brown agrees to pay a civil penalty under AS 21.34.230 in the amount of \$60,000, with \$30,000 suspended. The unsuspended portion of the penalty is payable within three months from the time that Brown is notified that the director has signed the order approving this agreement.

D12-10 Chartis Aerospace Adjustment Services, Inc. (Chartis)

Signed August 15, 2012, for unlicensed activity that occurred during the time the firm's license number 67366 was in a lapse status. Chartis agrees to pay a civil penalty under AS 21.27.440 in the amount of \$1,631.30, with \$800.00 suspended. The unsuspended portion of the penalty is payable at the time Chartis is notified that the director has signed the order approving this agreement.

D12-09 Clifford E. Rudolph

Signed July 18, 2012. On or about July 7, 2009, Mr. Rudolph submitted to the division an application for a non-resident insurance producer license. As Mr. Rudolph's application was complete and his answers on the application did not indicate any reason not to issue him a license, the division issued license number 79951, effective July 8, 2009. The division received a renewal application for Mr. Rudolph on September 22, 2010 and it was through this application the division became aware of administrative actions in 2007 and 2009, three criminal convictions in 1992 and one criminal conviction by a military court in 1996 all of which he should have reported on his initial application. Mr. Rudolph's failure to report the convictions and administrative actions are violations of AS 21.27.020, 21.27.025, and 21.27.410. Mr. Rudolph agrees to pay a civil penalty under AS 21.27.440 in the amount of \$2,000, with \$1,000 suspended. The civil penalty is payable at the time that Mr. Rudolph is notified that the director has signed the order approving this agreement.

D 12-08 Masae Fanene

Signed October 10, 2012. On or about April 6, 2011, Ms. Fanene submitted to the division an application for an individual in a firm insurance producer license. As Ms. Fanene's application was complete and her answers on the application did not indicate any reason not to issue her a license, the division issued license number 94241, effective April 13, 2011. In June 2011, the division received a criminal history report that revealed two misdemeanor convictions against Ms. Fanene that had not been disclosed on application. Ms. Fanene agrees to pay a civil penalty under AS 21.27.440 in the amount of \$500, with \$250 suspended. The civil penalty is payable at the time Ms. Fanene is notified

that the director has signed the order approving this agreement.

D 12-07 Socius Insurance Services, Inc. (Socius)

Signed July 12, 2012. Under AS 21.06.130, on October 24 and 25, 2011, the division performed a limited and targeted premium tax audit of Socius covering the period of January 1, 2009 through December 31, 2010. The audit report identified 75 violations of AS 21.34 that are within the control of Socius to correct in order to comply with Alaska insurance laws. The violations of AS 21.34 subject Socius to civil penalties under AS 21.34.230. Socius agrees to pay a civil penalty under AS 21.34.230 in the amount of \$40,000, with \$20,000 suspended. The unsuspended penalty is payable within three months from the time that Socius is notified that the director has signed the order approving this agreement.

D12-04 Medical Air Services Association (MASA)

Signed August 20, 2012. MASA is a membership association that sells an emergency transportation membership program in Alaska through its website and direct response selling. The division reviewed available MASA membership program information and determined that the MASA membership program is insurance and that MASA had been transacting insurance in Alaska without a certificate of authority as required under AS 21.09.010. Under the terms of the Agreement, MASA agrees that its website and any other website that may solicit or reference MASA memberships, including any advertising or promotional material accessible by Alaska consumers will make clear that MASA memberships are not available in Alaska. MASA also agrees that neither it or its affiliates or representatives will offer new MASA association memberships or seek new MASA business in Alaska and that if MASA or any affiliate or representative of MASA desires to resume business in Alaska in the future, MASA will notify the division and provide evidence that it is in compliance with Alaska laws before transacting any business in Alaska. MASA also agrees to not renew all current memberships of Alaska citizens and to not renew those members who move to Alaska upon receiving notice of the relocation of such a member.

D 12-03 The National Better Living Association (NBLA)

Signed October 4, 2012. NBLA is a membership association that the division alleges is subject to regulation by the division. NBLA sells membership packages that give members access to discounted savings on health care services through a network organization that has contracted with NBLA. NBLA does not have direct contracts with health care providers in Alaska as required under AS 21.36.505. NBLA has contracts with network organizations that, in turn, have contracts with the health care providers. NBLA agrees it will not issue a membership to an Alaska resident and NBLA's website or any other active website that NBLA controls that may solicit or reference NBLA memberships, including any advertising or promotional materials accessible by Alaska consumers will make clear that NBLA memberships are not available in Alaska. NBLA also agrees to terminate all current Alaska memberships and refund all membership fees as described in the agreement. By executing this agreement NBLA neither admits nor denies any wrongdoing.

D 12-01 Melissa J. Haxton

Rescission Order signed on October 15, 2012. On March 23, 2012, the director of the division signed an order adopting a Stipulated Agreement and Order in the Matter of: Melissa J. Haxton. Subsequently, the division performed an audit of the file of Ms. Haxton which revealed that the division had erred in its decision to take administrative action against Ms. Haxton for unlicensed activity regarding license number 60408. Although the division notified Ms. Haxton on August 19, 2011 that her insurance producer license had lapsed by mailing a notice to her that day, the division received a license renewal application from Ms. Haxton the same day. If a lapse notice is sent on the same day that a license renewal application is received by the division, it is standard practice for the division to withdraw the lapse notice and to process the renewal application without penalty. In the case of Ms. Haxton, the division failed to follow its standard practice and, instead of processing her license renewal application, the division took administrative action which resulted in the Stipulated Agreement and Order Number D 12-01. This order is rescinded and the civil penalty paid under that agreement will be refunded to Ms. Haxton. Her license records will reflect this rescission.

D 12-05, D 12-06, and D 12-02 were signed in FY 2012 and are included in the 2012 Annual Report. Suspension And Revocation Orders are on p. 20. There were no license denials.

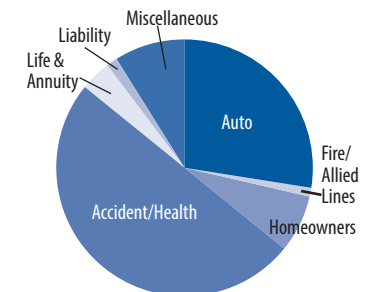
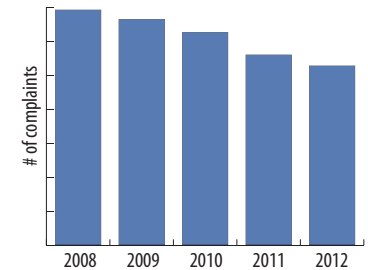

Advisory Organizations

Advisory Organizations, licensed by the division under AS 21.39.100, are organizations of insurers that assist insurers and rating organizations in rate making by collecting and furnishing loss and loss expense statistics or by submitting recommended rates or loss costs to the division. Advisory organizations include entities referred to elsewhere as statistical agents. Advisory organizations do not make filings on behalf of insurers.

Rating Organizations

Rating Organizations, licensed by the division under AS 21.39.060, make filings on behalf of insurers. Rating organizations may file policy forms, manual rules, loss costs, or final rates on behalf of member and subscriber insurers and must allow all insurers that desire to become members to do so. All rating organizations and insurers may cooperate in rate making to the extent permitted under AS 21.39.

Joint Underwriting Organizations

Joint underwriting organizations are groups of insurers formed to insure a specific risk (e.g. aviation, pollution, and large marine) that would otherwise be too large for one insurer to insure. Each individual insurer assumes a portion of the risk. Joint underwriting organizations are not licensed by the division but are subject to regulation under AS 21.39.110.

ACHIA

The Alaska Comprehensive Health Insurance Association (ACHIA) provides health insurance to Alaskans without coverage because of a pre-existing condition. The ACHIA-Fed plan was created to provide coverage to individuals with qualifying pre-existing health conditions who have been uninsured for at least six months pursuant to the Patient Protection and Affordable Care Act.

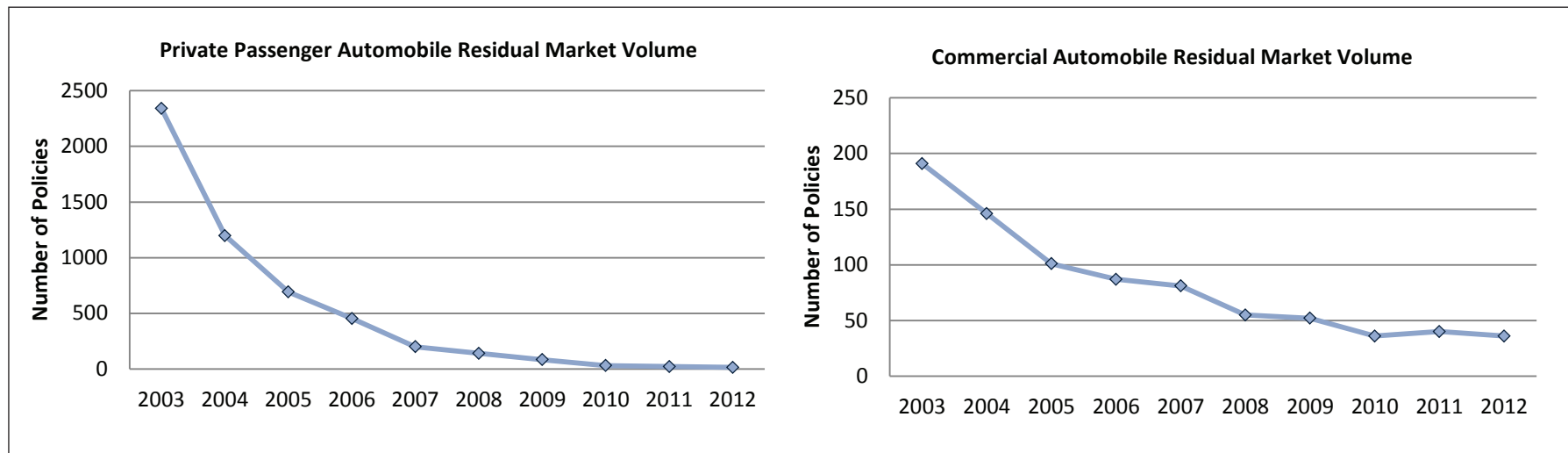
As of December 31, 2012, 542 individuals were covered under an ACHIA plan and 43 under the ACHIA-Fed plan. Detailed information about ACHIA and ACHIA-Fed is available at www.achia.com.

Alaska Automobile Plan

The Alaska Automobile Plan offers insurance for vehicle owners and operators unable to obtain insurance on a voluntary basis. Personal auto policy applications are submitted to AIPSO, a nonprofit management organization for groups administering the residual market, either directly or through an insurance agent, who then assigns the policies to insurers in proportion to each insurer's voluntary market share.

Commercial auto insurance is organized under a Servicing Carrier Program. Currently, all commercial auto assigned risk business is handled by Progressive Casualty Insurance Company and all commercial auto insurers share in the profit or loss of this business based upon each insurer's voluntary market share.

Automobile Residual Market Volume



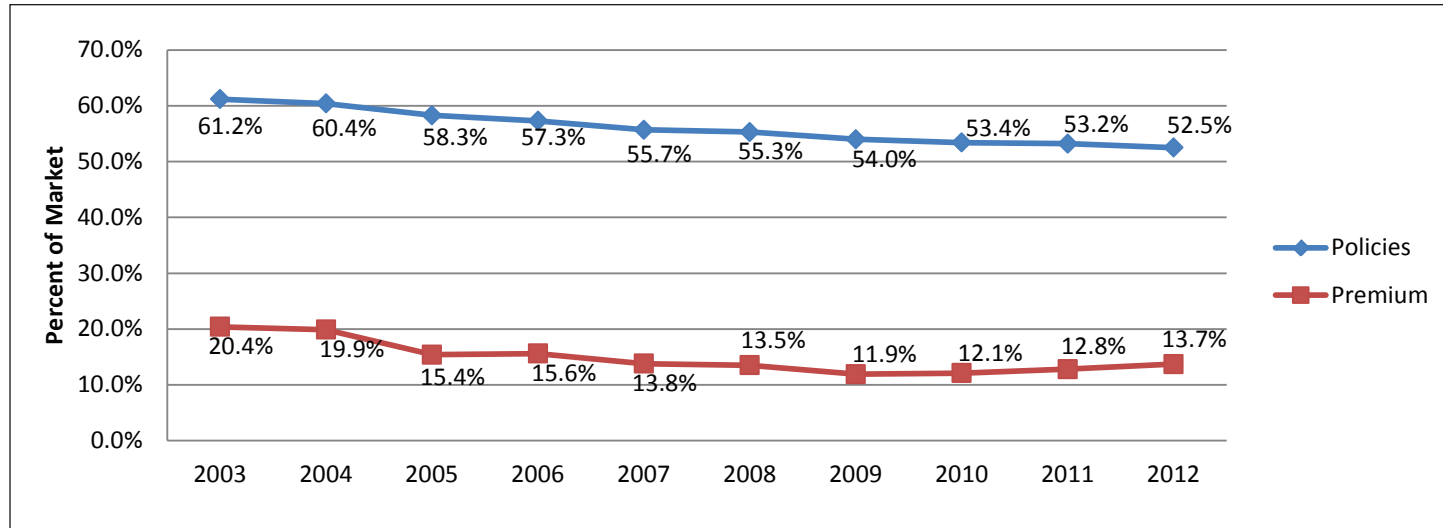
Workers' Compensation Assigned Risk Plan

Employers who are declined coverage by two non-affiliated insurers may obtain insurance through the Workers' Compensation Assigned Risk Plan either by assignment to a servicing carrier or to a direct assignment carrier. For the period January 1, 2012 through December 31, 2014, the servicing carriers are Alaska National Insurance Company, LM Insurance Corporation and Travelers Property Casualty Company of America. American Interstate Insurance Company is a direct assignment carrier. A direct assignment carrier is assigned policies in proportion to its voluntary market share while all other insurers share in the profit or loss of the policies assigned to the servicing carriers based upon each insurer's voluntary market share.

For 2012, the 7,923 assigned risk policies made up 52.5% of all workers' compensation policies. The \$32.4 million in premium was approximately 13.7% of total workers' compensation premium. 5,340 of the 7,923 assigned risk policy premiums were less than \$2,500.

The percentage of residual market policies peaked at 61.2% in 2003, gradually decreasing until becoming relatively constant in the last three years. Premium volume also peaked in 2003 and then decreased until 2009. Between 2009 and 2012, premium volume increased from 11.9% to 13.7%. This indicates that larger insureds, previously able to find coverage with a voluntary insurer, are now seeking coverage in the assigned risk market.
