STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Max A. Lamoureux (Mr. Lamoureux), the licensee in this case, stipulate and agree that the failure to timely renew license #242333 and the unlicensed activity that occurred during the time the license was in lapse status are resolved as follows:

1. Mr. Lamoureux admits that while his producer insurance license was in lapse status, from February 15, 2002 through February 22, 2002, he transacted the business of insurance, in violation of AS 21.27.380(b).
2. Prior to this instance, Mr. Lamoureux has never allowed his Alaska insurance license to lapse and, to the division's knowledge, he has not engaged in unlicensed activity.
3. Mr. Lamoureux agrees to pay a civil penalty under AS 21.27.440(a) of \$2,500, which equals the amount of commissions he earned for the unlicensed activity that occurred between February 15, 2002 and February 22, 2002, with \$1,250 suspended. The

2 unsuspended portion of the penalty is due at the time this agreement and order is signed by the  
3 director.

4 4. In the event Mr. Lamoureaux violates the insurance code or applicable  
5 regulations during the next two years (in particular, failure to renew his license timely), the  
6 suspended portion of the fine referenced in paragraph 3 will be reinstated. Mr. Lamoureaux  
7 also will be subject to any and all sanctions authorized by the insurance code including  
8 imposition of additional fines or penalties.

9  
10 5. By signing this agreement, Mr. Lamoureaux understands and agrees that  
11 any failure to comply with the conditions of this agreement will be grounds to revoke, suspend,  
12 or not renew Alaska insurance license #24233.

13 6. Mr. Lamoureaux understands that this agreement is not binding on the  
14 parties unless and until the director signs the order approving the agreement.




