10 STIPULATED AGREEMENT AND ORDER

11 The Division of Insurance (division) and Arthur A. Miguel (Mr. Miguel), the
12 licensee in this case, stipulate and agree that the failure to timely renew license #34345 and the
13 unlicensed activity that occurred during the time the license had lapsed are resolved as follows:

- 14 1. Mr. Miguel admits that between May 28, 2004 and December 10, 2004,
15 while his Alaska individual adjuster license was in lapse status, he transacted the business of
16 insurance, in violation of AS 21.27.380(b), for which he received no commissions.
- 17 2. Prior to this instance, to the division's knowledge, Mr. Miguel has not
18 engaged in unlicensed activity or otherwise violated the insurance code.
- 19 3. Mr. Miguel agrees to pay a civil penalty under AS 21.27.440(a) of \$800
20 for the unlicensed activity that occurred between May 28, 2004 and December 10, 2004, with
21 \$400 suspended. The unsuspended portion of the penalty is due at the time Mr. Miguel is
22 notified that the director has signed the order approving this agreement.
- 23 4. In the event Mr. Miguel violates the insurance code or applicable
24 regulations during the next two years, the suspended portion of the fine referenced in paragraph
25

1 3 will be reinstated. Mr. Miguel also will be subject to any and all sanctions authorized by the
2 insurance code including imposition of additional fines or penalties.

3 5. By signing this agreement, Mr. Miguel understands and agrees that any
4 failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or
5 not renew Alaska insurance license #34345.

7 6. Mr. Miguel understands that this agreement is not binding on the parties
8 unless and until the director signs the order approving the agreement.


