STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Navigant International (Navigant), and Pamela K. Munson, (Ms. Munson) Compliance Officer for Navigant, the licensees in this case, stipulate and agree that the unlicensed activity that occurred when Navigant and Ms. Munson were not appropriately licensed is resolved as follows:

1. Navigant and Ms. Munson were first issued limited insurance producer licenses #37294 and 37296 in 2004.
2. On February 9, 2006, the division notified Navigant and Ms. Munson that their insurance licenses had lapsed for failure to renew.
3. Prior to this instance, to the division's knowledge, Navigant and Ms. Munson have not engaged in unlicensed activity or otherwise violated the insurance code.
4. Navigant and Ms. Munson agree to pay a civil penalty under AS 21.27.440(a) in the amount of \$466.16, which equals the amount of commission earned for the unlicensed activity between February 5, 2006 and March 21, 2006, with \$266.16 suspended.

The unsuspended portion of the penalty is payable at the time Navigant and Ms. Munson are notified that the director has signed the order approving this agreement.


5. In the event Navigant and Ms. Munson violates the insurance code or applicable regulations during the next two years, the suspended portion of the fine referenced in paragraph 4 will be reinstated. Navigant and Ms. Munson also will be subject to any and all sanctions authorized by the insurance code including imposition of additional fines or penalties.

6. By signing this agreement, Navigant and Ms. Munson understand and agree that any failure to comply with the conditions of this agreement will be grounds to revoke, suspend, or not renew Alaska insurance licenses #37294 and 37296.

7. Navigant and Ms. Munson understand that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.




