STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Grant Getchell & Associates, Inc. (GGA), d/b/a Vancouver Insurance Agency, the licensee in this case, stipulate and agree that the unlicensed activity that occurred during the time license number 30862 was in lapse status is resolved as follows:

1. On November 1, 2006, the division sent GGA a license renewal application. On February 7, 2007, the division notified GGA that its firm insurance producer license had lapsed for failure to renew. The compliance officer was also notified of the options regarding his license because of the firm's lapse. That license also lapsed on May 17, 2007.

2. The division received the application requirements for both licenses on May 12, 2008. Before the licenses could be issued, the division required notarized statements regarding whether any Alaska business had been transacted. The statements indicated that business had been transacted on behalf of GGA between February 7, 2007 and June 2, 2008.

3. GGA agrees to pay a civil penalty under AS 21.27.440(a) in the amount of \$1,533, which equals the amount of compensation the firm earned between February 7, 2007

1 and June 2, 2008, with \$533 suspended. The unsuspended penalty is payable at the time that
2 GGA is notified that the director has signed the order approving this agreement.

3 4. In the event GGA or any individual in the firm violates the insurance
4 code or applicable regulations during the next two years, the suspended portion of the penalty
5 referenced in paragraph 3 will be reinstated. GGA also will be subject to any and all sanctions
6 authorized by the insurance code including imposition of additional fines or penalties.

7
8 5. By signing this agreement, GGA understands and agrees that any failure
9 to comply with the terms of this agreement may be grounds to revoke, further suspend, or non-
10 renew Alaska insurance license number 30862.

11 6. GGA understands that this agreement is not binding on the parties unless
12 and until the director signs the order approving the agreement.


