WHEREAS, a Certificate of Authority to transact the
business of insurance in the State of Alaska was issued to
LEGION INSURANCE COMPANY, domiciled in the Commonwealth of
Pennsylvania.

WHEREAS, the Commonwealth of Pennsylvania placed
LEGION INSURANCE COMPANY under an Order of Rehabilitation
dated March 28, 2002.

1 **WHEREAS**, the Certificate of Authority of **LEGION**
2 **INSURANCE COMPANY** to transact the business of insurance in
3 the state of Alaska was suspended effective May 3, 2002,
4 for a period of one year.

5
6 **IT IS HEREBY ORDERED**, pursuant to the provision of AS
7 21.09.150 (c) that Certificate of Authority No. F-619
8 issued to **LEGION INSURANCE COMPANY** to transact the business
9 of insurance in the State of Alaska shall be suspended for
10 a period of one year unless terminated sooner as permitted
11 by statute. Pursuant to AS 21.09.160(b), this suspension
12 shall automatically suspend the authority of all its agents
13 to act as agents of **LEGION INSURANCE COMPANY** in this state.

14
15 **IT IS FURTHER ORDERED**, that during the period of
16 suspension, **LEGION INSURANCE COMPANY** shall not solicit or
17 write any new business in the State of Alaska, but shall
18 file the Annual Statement, pay fees and any taxes due as
19 provided by AS 21.09.170(b).

20
21 **IT IS FURTHER ORDERED**, that Certificate of Authority
22 No. F-8054 will continue to be held in safekeeping by
23 **LEGION INSURANCE COMPANY** until such time as this Order of
24 Suspension is replaced by an Order of Revocation or the
25 Certificate of Authority is surrendered.
