

The capital contribution removed the surplus deficit reported at December 31, 2006.

**IT IS HEREBY ORDERED**, that in accordance with AS 21.09.170 (d) the Certificate of Authority issued to **AFFINITY ROAD & TRAVEL CLUB, INCORPORATED** shall be reinstated.
