**WHEREAS, TRENWICK AMERICA REINSURANCE CORPORATION** on September 2, 2003, executed a confidential Consent Order with the Connecticut Department of Insurance that included restrictions without limitations on the company's ability to accept, renew, modify, collateralize, commute, settle or modify its reinsurance obligations.

**WHEREAS, TRENWICK AMERICA REINSURANCE CORPORATION** operations have been in runoff since 2003 and the company is not writing any new business.

**WHEREAS,** Certificate of Authority No. F-8093 issued to **TRENWICK AMERICA REINSURANCE CORPORATION** to transact the business of insurance in the State of Alaska will expire on June 27, 2010 as there has been no satisfactory evidence presented that **TRENWICK AMERICA REINSURANCE CORPORATION** has resolved the findings under AS 21.09.140 (a) (3) within five years after the date of suspension.
