ACCUSATION AND FINAL ORDER

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of
Commerce, Community, and Economic Development (DCCED), State of Alaska, states
the issues on which the accusation is based as follows:

1. On March 26th, 2023, **EDWARD DONTAY MUSGROVE**
(MUSGROVE), domiciled in the State of Tennessee applied for
Insurance Producer license with Life authority with the Division to
conduct business in the State of Alaska.
2. Upon review of the application, **MUSGROVE** responded negatively to
background question 2, indicating no administrative actions to report to
the State of Alaska.

- 1 3. The Producer Database and the Attachment Warehouse reflects
2 administrative action was taken against **MUSGROVE** in State of
3 California in effect on November 30th, 2007. **MUSGROVE** failed to
4 disclose his administrative action to the Division and provided inaccurate
5 information on his application.

7 4. On March 31st, 2023, correspondence was provided to **MUSGROVE**
8 informing of its failure to respond accurately to background question 2
9 regarding administrative actions. The Division provided **MUSGROVE** the
10 opportunity to voluntarily withdraw the application and provide a new,
11 complete, and accurate application within 15 days. No response was
12 received.

14 5. Alaska Statute (AS) 21.27.040(a) states that "(a) Application for a license
15 shall be made to the director upon forms prescribed by the director. As a
16 part of or in connection with the application, the applicant shall furnish
17 information concerning the applicant's identity, personal history,
18 experience, business record, purposes, and other pertinent facts that the
19 director may reasonably require. The applicant shall declare, subject to
20 penalty of denial, nonrenewal, suspension, or revocation of a license
21 issued by the director, that the statements made in or in connection with
22 the application are true, correct, and complete to the best of the applicant's
23 knowledge and belief..."

25 6. AS 21.27.020(a) provides: "For the protection of the people of this state,
26 the director may not issue or renew a license except in compliance with


this chapter and not issue a license to a person, or to be exercised by a person, found by the director to be untrustworthy, incompetent, or who has not established to the satisfaction of the director that the person is qualified under this chapter."

- 7. AS 21.27.020(b)(4) provides: "To qualify for issuance or renewal of an individual license, an applicant or licensee shall (4) be a trustworthy person."
- 8. Pursuant to AS 21.27.040(a), **MUSGROVE** provided inaccurate information at the time of application. Based on the above **MUSGROVE's** Insurance Producer license application is hereby DENIED.

ORDER

IT IS HEREBY ORDERED, under the provisions of AS 21.27.040(a) **EDWARD DONTAY MUSGROVE's** application for the Insurance Producer license in Alaska under National Producer Number (NPN) # 10060230 is DENIED for supplying inaccurate information on the application for licensure. **EDWARD DONTAY MUSGROVE** may seek licensure in Alaska after a period of 30 days has lapsed after the effective date of this ORDER.
