Alaska's businesses manufacture high quality, unique, and sought-after products for markets locally, nationally, and internationally. The recognizable mother bear and cub symbol provides assurance for consumers that a product was produced in Alaska by local manufacturers and artisans.

The MIA program is used to identify and promote the purchase of products manufactured or crafted in Alaska, ranging from small gift items to large industrial products.
