**WHEREAS**, **REPUBLIC MORTGAGE INSURANCE COMPANY** has failed to present satisfactory evidence that its condition no longer renders its continuation of business to be hazardous to the public and its policyholders within five years of the date of its suspension as required under AS 21.09.170 (d).

**IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.170 (d), that Certificate of Authority No. F-1233 issued to **REPUBLIC MORTGAGE INSURANCE COMPANY** to transact the business of insurance in the State of Alaska, expires February 7, 2017. Pursuant to AS 21.09.160 (b), this expiration shall automatically revoke the authority of all its agents to act as agents of **REPUBLIC MORTGAGE INSURANCE COMPANY** in this state.
