### STIPULATED AGREEMENT AND ORDER

The Division of Insurance (division) and Brown and Riding Insurance Services Inc., (Brown), the licensee in this case, stipulate and agree to the following:

### I. BACKGROUND

- A. Brown holds surplus lines broker license number 93079.
- B. Under AS 21.06.120, the division performed a limited and targeted premium tax audit of Brown's surplus lines business for the period July 1, 2017 through June 30, 2019. The audit was completed and a report and order approving the report were issued on May 7, 2020 under TA 19-05. Both were sent to Brown on May 17, 2020.
- C. Under one failed audit test in the audit report, 6 violations of AS 21.34 were identified as being within the control of Brown to correct in order to comply with Alaska insurance laws.
- D. These 6 violations of AS 21.34 subjects Brown to civil penalties under AS 21.34.230.

### II. TERMS OF AGREEMENT

- 1. The division agrees that the next audit performed on Brown related hereto will exclude any quarter ending before January 1, 2021.
- 2. For the TA 19-05 audit violations, Brown agrees to pay a civil penalty under AS 21.34.230 in the amount of \$10,000 with \$5,000 suspended. The unsuspended penalty of \$5,000 is payable within three months of the date that Brown is notified that the director has signed the order approving this agreement.
- 3. In the event Brown is found to have violated the Alaska insurance laws during the next audit resulting in failed findings, the suspended portion of the penalty referenced in paragraph 2 will be reinstated. Brown also will be subject to any and all sanctions authorized by the insurance laws including imposing additional penalties.
- 5. By signing this agreement, Brown understands and agrees that any failure to comply with the terms of this agreement may be grounds to revoke, suspend, or non-renew Alaska surplus lines broker license number 93079.
- 6. Brown understands that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
