11	IZATT informing the firm that their license expired for failure to renew
12	timely.
13	E. On October 7, 2024, an application was received to reinstate the
14 15	MELISSA IZATT's Insurance Producer license. The Division requested a
16	Business Transaction Form (BTF) in support of MELISSA IZATT's
17	reinstatement application.
18	F. On October 15, 2024, a BTF was submitted by MELISSA IZATT. In the
19	BTF 8 policies were issued between September 24, 2024, and October 3,
20 21	2024, resulting in \$4003 in commission received by MELISSA IZATT.
22	The same day the Division reinstated MELISSA IZATT's license
23	authorizing MELISSA IZATT to transact the business of insurance in the

26	G. On November 1, 2024, the Division sent correspondence detailing a

11	which subjects MELISSA IZATT to civil penalties. AS 21.27.440(a)
12	provides that "in addition to any other penalties provided by law, a person
13	that the director determines under AS 21.06.170-21.06.240 has violated
14 15	the provisions of this chapter is subject to (1) a civil penalty equal to the
16	compensation promised, paid, provided, or to be paid, directly or
17	indirectly, to a person in regard to each violation; (2) either a civil penalty
18	of not more than \$10,000 for each violation or a civil penalty of not more
19	than \$25,000 for each violation if the director determines that the person
20 21	willfully violated the provisions of this chapter; and (3) denial,
22	nonrenewal, suspension, or revocation of a license." The director has the
23	latitude to impose civil penalties against a person who has violated
24	Alaska's insurance laws.
