13 14	I. BACKGROUND
14	A. Aon Risk holds surplus lines broker license number 20376.
15	B. Under AS 21.06.120, the division performed a limited and targeted premium tax audit
10	of Aon Risk's surplus lines business for the period July 1, 2022, through June 30, 2024. The audit
18	was completed and a report and order approving the report were issued on April 28, 2025, under
10	TA 24-04. Both were sent to Aon Risk on May 2, 2025.
20	C. Under six failed finding in the audit report, 216 violations of AS 21.34 were identified
21	as being within the control of Aon Risk to correct in order to comply with Alaska insurance laws.
22	D. These 216 violations of AS 21.34 subjects Aon Risk to civil penalties under AS
23	21.34.230.

The unsuspended penalty of \$30,000 5 is payable within three months of the date Aon Risk is notified the director has signed the order 6 approving this agreement. 7 3. In the event Aon Risk is found to have violated the Alaska insurance laws during the 8 next audit resulting in failed findings, the suspended portion of the penalty referenced in paragraph 9 2 will be reinstated. Aon Risk also will be subject to any and all sanctions authorized by the 10 insurance laws including imposing additional penalties. 11 5. By signing this agreement, Aon Risk understands and agrees that any failure to 12 comply with the terms of this agreement may be grounds to revoke, suspend, or non-renew Alaska 13 surplus lines broker license number 20376. 14 6.
