STIPULATED AGREEMENT AND ORDER

The State of Alaska Department of Commerce, Community, and Economic Development, Division of Insurance (Division), RIEMERINSURANCE GROUP INC (RIEMERINSURANCE), the producer in this case, stipulate and agree to the following:

BACKGROUND

A. On September 17, 2015, the Division issued an initial Insurance Producer license with Property and Casualty authority, license number 100123581, to RIEMERINSURANCE domiciled in the State of Florida. This license has an expiration date of September 17 of odd numbered years.

- B. On August 22, 2018, the Division received correspondence from Rinaldo Sidky,
 Authorized Submitter of Request to Cancel License effective September 30,
 2018. RIEMERINSURANCE license was cancelled per the request on August
 22, 2018, and is cancelled status.
- C. On February 2, 2024, in a routine audit the Division discovered that REIMERINSURANCE issued policies on August 17, 2022, while their license was in cancelled status.
- D. On February 14, 2024, correspondence was issued to RIEMERINSURANCE requesting clarification of business transacted without a valid license. The Division informed RIEMERINSURANCE that a formal investigation is in process. The Division requested the firm to provide a complete Business Transaction Form (BTF) and a response by March 1, 2024. No response was received.
- E. On April 18, 2024, the Division sent an additional correspondence to

 REIMERINSURANCE indicating the Division's intent to license revocation

 since RIEMERINSURANCE did not respond to settle the violation of Alaska

 Statutes. REIMERINSURANCE did not respond.
- F. On April 30, 2024, John Holley, Investigator III assigned by the Division requested additional information of the alleged unlicensed business of RIEMERINSURANCE from CRC Insurance Services, Inc (CRC Group).
- G. On May 9, 2024, the Division received an application to reinstate the Insurance Producer license of RIEMERINSURANCE. The firm license was reinstated on May 17, 2024.

H. On December 19, 2024, the Director signed the initial revocation order SR24-36 initiating the Notice of Rights period for REIMERINSURANCE.
 REIMERINSURANCE had 15 days to respond to request a hearing, as are the established rights of a licensee pursuant to Alaska Statute (AS) 21.06.180.

- On January 2, 2025, the Division received correspondence from REIMERINSURANCE requesting to settle the initial order SR24-36 and the Division honored the request.
- J. On April 29, 2025, the Division sent correspondence a proposed settlement to REIMERINSURANCE and assessed a civil penalty in the amount of \$2,290 with \$1,145 suspended. The unsuspended penalty of \$1,145 is payable to the Division.
- K. On May 6, 2025, **REIMERINSURANCE** accepted the proposed penalty assessed.

II. TERMS OF AGREEMENT

A. Between **REIMERINSURANCE**'s cancellation date of August 22, 2018, and the reinstatement date of May 17, 2024, seven (7) total policies were transacted prior to the license reinstatement on of May 17, 2024, and were in violation of AS 21.27.010 which subjects **REIMERINSURANCE** to civil penalties. AS 21.27.440(a) provides that "in addition to any other penalties provided by law, a person that the director determines under AS 21.06.170-21.06.240 has violated the provisions of this chapter is subject to (1) a civil penalty equal to the compensation promised, paid, or to be paid, directly or indirectly, to a person in regard to each violation; (2) either a civil penalty of not more than \$10,000 for

each violation or a civil penalty of not more than \$25,000 for each violation if the director determines that the person willfully violated the provisions of this chapter; and (3) denial, nonrenewal, suspension, or revocation of a license." The director has the latitude to impose civil penalties against a person who has violated Alaska's insurance laws.

- B. REIMERINSURANCE further agrees to pay the civil penalty in the amount of \$2,290 for activity that occurred prior to the reinstatement of firm license with \$1,145 suspended. The unsuspended portion of \$1,145 must be received by the Division within 30 days of the signature finalizing this agreement.
- C. In the event **RIEMERINSURANCE** is found to have violations of the Alaska insurance laws during the next two years, the suspended portion of the penalty of \$1,145 referenced in section II. B. will be reinstated.

REIMERINSURANCE also will be subject to any and all sanctions authorized by the insurance laws including imposition of additional penalties regarding any such violation.

- D. By signing this agreement, **REIMERINSURANCE** understands and agrees that any failure to comply with the terms of this agreement will be grounds to revoke, suspend, or non-renew license number 100123581.
- E. REIMERINSURANCE understand that this agreement is not binding on the parties unless and until the director signs the order approving the agreement.
