WHEREAS, SENIOR HEALTH INSURANCE COMPANY OF PENNSYLVANIA's Certificate of Authority has been suspended in the States of Idaho, Utah and Washington.

WHEREAS IT IS HEREBY ORDERED, pursuant to the provisions of AS 21.09.140 (a) (2), that Certificate of Authority No. F-8062 issued to **SENIOR HEALTH INSURANCE COMPANY OF PENNSYLVANIA** to transact the business of insurance in the State of Alaska shall be suspended until such time as it has returned to full compliance with Alaska Statutes unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160(b), this suspension shall automatically suspend the authority of all of its agents to act as agents of **SENIOR HEALTH INSURANCE COMPANY OF PENNSYLVANIA.**

IT IS FURTHER ORDERED that during this period of suspension, **SENIOR HEALTH INSURANCE COMPANY OF PENNSYLVANIA** shall continue to file the annual statement and pay fees and any taxes due as provided by AS 21.09.170(b).
