Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all of its agents to act as agents of **AMERICAN SERVICE INSURANCE COMPANY**.

IT IS FURTHER ORDERED that during this period of suspension, **AMERICAN SERVICE INSURANCE COMPANY** shall continue to file the annual statement and pay fees and any taxes due as provided by AS 21.09.170 (b).

IT IS FURTHER ORDERED that Certificate of Authority No. F-10593 will continue to be held in safekeeping by **AMERICAN SERVICE INSURANCE COMPANY** until such time as this order is replaced by an Order of Revocation, the Certificate of Authority is surrendered or the Certificate of Authority expires.
