WHEREAS, a Certificate of Authority to transact the business of insurance in the State of Alaska was issued to **AMERICAS INSURANCE COMPANY**, domiciled in the District of Columbia.

WHEREAS, on February 2, 2022, an Order on Amended Verified Petition for Rehabilitation and Injunctive Relief, was issued by the Insurance Commissioner for the Sate of Louisiana.

WHEREAS, the order placed **AMERICAS INSURANCE COMPANY** in Rehabilitation and Receivership, appointing James J. Donelon, Commissioner of Insurance for the State of Louisiana, as Rehabilitator, and Billy Bostick as

Receiver by the 19th Judicial District Court, Parish of East Baton Rouge, State of Louisiana.

IT IS HEREBY ORDERED, pursuant to the provisions of AS 21.09.140 (a) (3), that Certificate of Authority No. F-8180 issued to **AMERICAS INSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be suspended until such time as it has returned to full compliance with Alaska Statutes unless terminated sooner as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all its agents to act as agents of **AMERICAS INSURANCE COMPANY** in Alaska.

IT IS FURTHER ORDERED that during the period of suspension, **AMERICAS INSURANCE COMPANY** shall continue to file the annual statement and pay fees and any taxes due as provided by AS 21.09.170 (b).

IT IS FURTHER ORDERED that Certificate of Authority No. F-8180 will continue to be held in safekeeping by **AMERICAS INSURANCE COMPANY** until such time as this order is replaced by an Order of Revocation, the Certificate of Authority is surrendered, or the Certificate of Authority expires.
