**WHEREAS**, a Certificate of Authority to transact the business of insurance in the State of Alaska was issued to **GO INSURANCE COMPANY**, domiciled in Oklahoma.

**WHEREAS**, on December 18, 2023, an Agreed Order Placing Go Insurance Company into Receivership, Appointing a Receiver, Granting Injunctive Relief, and Ordering Rehabilitation with Consent was issued by the Commissioner of Insurance of the State of Oklahoma, District Court, Oklahoma County.

**WHEREAS**, it was ordered and decreed that **GO INSURANCE COMPANY** is insolvent and remains impaired, and is in a condition such that

the continued operations would be hazardous to the policyholders, the creditors of the insurer, or the general public.

**IT IS HEREBY ORDERED**, pursuant to the provisions of AS 21.09.140 (a) (2) and (3), that Certificate of Authority No. F-10599 issued to **GO INSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be revoked. Pursuant to AS 21.09.160 (b), this revocation shall automatically revoke the authority of all its agents to act as agents of **GO INSURANCE COMPANY** in Alaska.

**IT IS FURTHER ORDERED** that Certificate of Authority No. F-10599 held by **GO INSURANCE COMPANY** shall be returned to the Alaska Division of Insurance by April 8, 2024.
