18 WHEREAS, a Certificate of Authority to transact the
19 business of insurance in the State of Alaska has been issued to
20 NORTHWESTERN NATIONAL INSURANCE COMPANY OF MILWAUKEE,
21 WISCONSIN, domiciled in Wisconsin.

22 WHEREAS, NORTHWESTERN NATIONAL INSURANCE COMPANY OF
23 MILWAUKEE, WISCONSIN entered into voluntary runoff in 1986. On
24 November 10, 1989, the Wisconsin Commissioner of Insurance
25 ordered the run-off of all business of the company and the
26 cessation of writing any new and renewal business.

WHEREAS, the Certificate of Authority for NORTHWESTERN
NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN, to transact
the business of insurance in the State of Alaska was suspended
effective December 28, 1992, and that suspension has been
continued to the present.

1 WHEREAS, The 1999 Annual Statement of **NORTHWESTERN**
2 **NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN** showed
3 during 1999 they continued in runoff status and are not writing
4 any new business.

5 It is hereby ordered, pursuant to the provision of AS
6 21.09.140(a)(2) that Certificate of Authority No F-0652 issued
7 to **NORTHWESTERN NATIONAL INSURANCE COMPANY OF MILWAUKEE,**
8 **WISCONSIN** to transact the business of insurance in the state of
9 Alaska shall be suspended for a period of one year unless
10 terminated sooner as permitted by statute. Pursuant to AS
11 21.09.160(b), this suspension shall automatically suspend the
12 authority of all its agents to act as agents of **NORTHWESTERN**
13 **NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN** in this
14 state.

15 During the period of suspension, **NORTHWESTERN NATIONAL**
16 **INSURANCE COMPANY OF MILWAUKEE, WISCONSIN** shall not solicit or
17 write any new business in Alaska, but shall file the Annual
18 Statement, pay fees and any taxes due as provided by AS
19 21.09.170(b).

20 It is further ordered that Certificate of Authority No. F-
21 0652 will continue to be held in safekeeping by **NORTHWESTERN**
22 **NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN** until such
23 time as this Order of Suspension is lifted or is replaced by an
24 Order of Revocation.

25 This order is effective the 28th day of December 2000.
