**WHEREAS**, the Order of Liquidation states that, “All references to “Reliance” herein shall include the former subsidiaries which were previously merged into Reliance by the approval of the Commissioner, including Reliance National Indemnity Company, Reliance National Insurance Company, United Pacific Insurance Company, Reliance Direct Company, Reliance Surety Company, Reliance Universal Insurance Company, United Pacific Insurance Company of New York and Reliance Insurance Company of Illinois.”

**WHEREAS, RELIANCE UNIVERSAL INSURANCE COMPANY** failed to properly notify the State of Alaska of the change in corporate structure which took place before the issuance of the Order of Liquidation.

**WHEREAS, RELIANCE UNIVERSAL INSURANCE COMPANY** failed to submit the 2000 annual statement due on March 1, 2001 as required under AS 21.09.200.


**IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140 (a) (2) that certificate of authority No. F-10022 issued to **RELIANCE UNIVERSAL INSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be revoked. The authority of all persons to act as agents of **RELIANCE UNIVERSAL INSURANCE COMPANY** in the State of Alaska shall also be revoked.
