2 1994. The order appointed the Commissioner of Insurance of the Commonwealth
3 of Massachusetts as Permanent Receiver to rehabilitate the company and conserve
4 its assets. The company remains in rehabilitation at the present time.

6 **WHEREAS**, the Certificate of Authority for **MONARCH LIFE**
7 **INSURANCE COMPANY**, to transact the business of insurance in the State of
8 Alaska was suspended effective July 28, 1994, and that suspension has been
9 continued to the present.
10

11 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.150(c)
12 that Certificate of Authority No F- 1311 issued to **MONARCH LIFE**
13 **INSURANCE COMPANY** to transact the business of insurance in the State of
14 Alaska shall continue to be suspended for a period of one year unless terminated
15 sooner as permitted by statute. Pursuant to AS 21.09.160(b), this suspension shall
16 automatically suspend the authority of all its agents to act as agents of
17 **MONARCH LIFE INSURANCE COMPANY** in this state.

20 During the period of suspension, **MONARCH LIFE INSURANCE**
21 **COMPANY** shall not solicit or write any new or renewal business in Alaska, but
22 shall file the Annual Statement, pay fees and any taxes due as provided by AS
23 21.09.170(b).
