**WHEREAS**, a Certificate of Authority to transact the  
business of insurance in the State of Alaska was issued to  
**US INTERNATIONAL REINSURANCE COMPANY**, domiciled in the  
State of New Hampshire.

**WHEREAS**, the Superior Court of the State of New  
Hampshire placed **US INTERNATIONAL REINSURANCE COMPANY** under

1 an Order of Supervision on March 3, 1997, which continues  
2 to this day.

3  
4 **WHEREAS**, the Certificate of Authority of **US**  
5 **INTERNATIONAL REINSURANCE COMPANY** to transact the business  
6 of insurance in the State of Alaska was suspended effective  
7 May 22, 2002, for a period of one year.

8  
9 **IT IS HEREBY ORDERED**, pursuant to the provision of AS  
10 21.09.140 (a) (3) that Certificate of Authority No. F-1676  
11 issued to **US INTERNATIONAL REINSURANCE COMPANY** to transact  
12 the business of insurance in the State of Alaska shall be  
13 suspended for a period of one year unless terminated sooner  
14 as permitted by statute. Pursuant to AS 21.09.160(b), this  
15 suspension shall automatically suspend the authority of all  
16 its agents to act as agents of **US INTERNATIONAL REINSURANCE**  
17 **COMPANY** in this state.

18  
19 **IT IS FURTHER ORDERED**, that during the period of  
20 suspension, **US INTERNATIONAL REINSURANCE COMPANY** shall not  
21 solicit or write any new business in the State of Alaska,  
22 but shall file the Annual Statement, pay fees and any taxes  
23 due as provided by AS 21.09.170(b).

25 **IT IS FURTHER ORDERED**, that Certificate of Authority  
26 No. F-1676 will continue to be held in safekeeping by **US**  
27 **INTERNATIONAL REINSURANCE COMPANY** until such time as this


