24 in the State of Alaska was issued to NORTHWESTERN NATIONAL
25 INSURANCE COMPANY OF MILWAUKEE, WISCONSIN, domiciled in

1 **WHEREAS**, the Certificate of Authority issued to **NORTHWESTERN**
2 **NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN** to
3 transact the business of insurance in the State of Alaska was suspended on
4 December 28, 1992 and that suspension has been continued to the present.

7 **WHEREAS**, the last annual statement received for **NORTHWESTERN**
8 **NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN**
9 being the 2003 Annual Statement shows that the company fails to meet the
10 minimum capital and surplus requirements of AS 21.09.070 for the kinds of
11 insurance authorized.

15 **WHEREAS**, AS 21.09.140 (a) (2) states that the director shall suspend or
16 revoke an insurer's Certificate of Authority if the insurer no longer meets the
17 requirements for the authority granted, on account of the insurer becoming
18 impaired or insolvent or otherwise.



21 **IT IS HEREBY ORDERED**, pursuant to the provision of AS 21.09.140 (a)
22 (2) that Certificate of Authority No. F- 0652 issued to **NORTHWESTERN**
23 **NATIONAL INSURANCE COMPANY OF MILWAUKEE, WISCONSIN** to
24 transact the business of insurance in the State of Alaska shall be revoked.
25 Pursuant to AS 21.09.160 (b), this revocation shall automatically revoke the
26 authority of all its agents to act as agents for it in this state.
