WHEREAS, the Certificate of Authority issued to **TRENWICK AMERICA REINSURANCE CORPORATION** to conduct the business of insurance in the State of Alaska was suspended effective June 27, 2003 and that suspension has continued in effect to the present time.

WHEREAS on September 2, 2003, **TRENWICK AMERICA REINSURANCE CORPORATION** executed a confidential Consent Order with the Connecticut Insurance Department that included restrictions without limitations on the company's ability to accept, renew, modify, collateralize, commute, settle or modify its reinsurance obligations.

IT IS HEREBY ORDERED, pursuant to the provision of AS 21.09.140(a) (3) that Certificate of Authority No. 8093 issued to **TRENWICK AMERICA REINSURANCE CORPORATION** to transact the business of insurance in the State of Alaska shall be suspended until such time as all orders issued in its domestic state are removed resulting in the insurer's return to good standing in its state of domicile. Pursuant to AS 21.09.160 (b), this suspension shall automatically suspend the authority of all its agents to act as agents of the **TRENWICK AMERICA REINSURANCE CORPORATION** in this state.
