WHEREAS, a Certificate of Authority to transact the business of insurance

1 **WHEREAS**, the Certificate of Authority issued to **WESTERN UNITED**
2 **LIFE ASSURANCE COMPANY** to transact the business of insurance in the
3 State of Alaska was suspended on March 10, 2004 for a period of one year.

6 **IT IS HEREBY ORDERED**, pursuant to the provision of
7 AS 21.09.150(c) that Certificate of Authority No. F-1681 issued to **WESTERN**
8 **UNITED LIFE ASSURANCE COMPANY** to transact the business of insurance
9 in the State of Alaska shall be suspended until such time as the insurer has
10 returned to full compliance with Alaska Statutes and all orders issued in its
11 domestic state are removed resulting in the insurer's return to good standing in its
12 state of domicile. Pursuant to AS 21.09.160 (b), this suspension shall
13 automatically suspend the authority of all of its agents to act as agents of
14 **WESTERN UNITED LIFE ASSURANCE COMPANY** in this state.

19 **IT IS FURTHER ORDERED**, that during the period of the suspension,
20 **WESTERN UNITED LIFE ASSURANCE COMPANY** shall not solicit or
21 write any new business in the State of Alaska but shall file its Annual Statement,
22 pay fees and any taxes due as provided by AS 21.09.170(b).

25 **IT IS FURTHER ORDERED**, that Certificate of Authority No. F-1681
26 will continue to be held in safekeeping by **WESTERN UNITED LIFE**
