10 it has returned to full compliance with Alaska Statutes unless terminated sooner
11 as permitted by statute. Pursuant to AS 21.09.160 (b), this suspension shall
12 automatically suspend the authority of all of its agents to act as agents of
13 **PROFESSIONAL LIABILITY INSURANCE COMPANY OF AMERICA** in


