**ACCUSATION AND FINAL ORDER**

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of  
Commerce, Community, and Economic Development (DCCED), State of Alaska, states  
the issues on which the accusation is based as follows:

1. On September 16, 2024, **NICKOLE HOLLANDER (HOLLANDER)**,  
domiciled in the State of Kansas applied for an Insurance Producer license  
requesting Personal Lines authority with the Division to conduct business  
in the State of Alaska.
2. Upon review of the application, **HOLLANDER** responded negatively to  
background question 2, indicating no administrative action to report to the  
State of Alaska.

- 1 3. The Producer Database and the Attachment Warehouse reflects  
2 administrative action was taken against **HOLLANDER** in the State of  
3 Kansas in effect September 11, 2024. **HOLLANDER** failed to disclose  
4 her administrative action to the Division and provided inaccurate  
5 information on her application.  
6
- 7 4. On September 18, 2024, correspondence was provided to **HOLLANDER**  
8 informing of her failure to respond accurately to a background question  
9 regarding administrative actions. The Division provided **HOLLANDER**  
10 the opportunity to voluntarily withdraw the application and provide a new,  
11 complete, and accurate application within 30 days. No response was  
12 received.  
13
- 14 5. Alaska Statute 21.27.040(a) states that "(a) Application for a license shall  
15 be made to the director upon forms prescribed by the director. As a part of  
16 or in connection with the application, the applicant shall furnish  
17 information concerning the applicant's identity, personal history,  
18 experience, business record, purposes, and other pertinent facts that the  
19 director may reasonably require. The applicant shall declare, subject to  
20 penalty of denial, nonrenewal, suspension, or revocation of a license  
21 issued by the director, that the statements made in or in connection with  
22 the application are true, correct, and complete to the best of the applicant's  
23 knowledge and belief..."  
24
- 25 6. AS 21.27.020(a) provides: "For the protection of the people of this state,  
26 the director may not issue or renew a license except in compliance with  
27  
28

1 this chapter and not issue a license to a person, or to be exercised by a  
2 person, found by the director to be untrustworthy, incompetent, or who  
3 has not established to the satisfaction of the director that the person is  
4 qualified under this chapter."  
5

6 7. AS 21.27.020(b)(4) provides: "To qualify for issuance or renewal of an  
7 individual license, an applicant or licensee shall (4) be a trustworthy  
8 person."  
9

10 8. Pursuant to AS 21.27.040(a), **HOLLANDER** provided inaccurate  
11 information at the time of application. Based on the above  
12 **HOLLANDER** Insurance Producer license application is hereby  
13 DENIED.  
14

15 ORDER

16 **IT IS HEREBY ORDERED**, under the provisions of AS 21.27.040(a) that **NICKOLE**  
17 **HOLLANDER** application for the Insurance Producer license in Alaska under National  
18 Producer Number (NPN) # 21121340 is DENIED for supplying inaccurate information  
19 on the application for licensure.
