ACCUSATION AND FINAL ORDER

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of Commerce, Community, and Economic Development (DCCED), State of Alaska, states the issues on which the accusation is based as follows:

1. On June 10, 2024, **CONNOR T MURPHY (MURPHY)**, domiciled in the State of Massachusetts applied for an Insurance Producer license requesting Casualty, and Property Lines of authority with the Division to conduct business in the State of Alaska.
2. Upon review of the application, **MURPHY** responded negatively to background question 2, indicating no administrative action to report to the State of Alaska.

- 1 3. The Producer Database and the Attachment Warehouse reflects
2 administrative action was taken against **MURPHY** in the State of Georgia
3 in effect December 26, 2012. **MURPHY** failed to disclose his
4 administrative action to the Division and provided inaccurate information
5 on his application.
6
- 7 4. On July 24, 2024, correspondence was provided to **MURPHY** informing
8 of his failure to respond accurately to a background question regarding
9 administrative actions. The Division provided **MURPHY** the opportunity
10 to voluntarily withdraw the application and provide a new, complete, and
11 accurate application within 30 days. No response was received.
12
- 13 5. Alaska Statute 21.27.040(a) states that "(a) Application for a license shall
14 be made to the director upon forms prescribed by the director. As a part of
15 or in connection with the application, the applicant shall furnish
16 information concerning the applicant's identity, personal history,
17 experience, business record, purposes, and other pertinent facts that the
18 director may reasonably require. The applicant shall declare, subject to
19 penalty of denial, nonrenewal, suspension, or revocation of a license
20 issued by the director, that the statements made in or in connection with
21 the application are true, correct, and complete to the best of the applicant's
22 knowledge and belief..."
23
- 24 6. AS 21.27.020(a) provides: "For the protection of the people of this state,
25 the director may not issue or renew a license except in compliance with
26 this chapter and not issue a license to a person, or to be exercised by a
27 this chapter and not issue a license to a person, or to be exercised by a
28 this chapter and not issue a license to a person, or to be exercised by a
29

1 person, found by the director to be untrustworthy, incompetent, or who
2 has not established to the satisfaction of the director that the person is
3 qualified under this chapter."
4

5 7. AS 21.27.020(b)(4) provides: "To qualify for issuance or renewal of an
6 individual license, an applicant or licensee shall (4) be a trustworthy
7 person."
8

9 8. Pursuant to AS 21.27.040(a), **MURPHY** provided inaccurate information
10 at the time of application. Based on the above **MURPHY** Insurance
11 Producer license application is hereby DENIED.
12

13 ORDER

14 **IT IS HEREBY ORDERED**, under the provisions of AS 21.27.040(a) that **CONNOR T**
15 **MURPHY** application for the Insurance Producer license in Alaska under National
16 Producer Number (NPN) # 16551364 is DENIED for supplying inaccurate information
17 on the application for licensure.


