# NOTICE OF PROPOSED CHANGES ON PROXY SOLICITATIONS FOR ANCSA CORPORATIONS IN THE REGULATIONS OF THE DEPARTMENT OF COMMERCE, COMMUNITY, AND ECONOMIC DEVELOPMENT

#### **BRIEF DESCRIPTION**

The Department of Commerce, Community, and Economic Development proposes to change regulations dealing with solicitations of proxies for Alaska Native Claims Settlement Act (ANCSA) corporations and to repeal obsolete text in accordance with changes in state law.

The Department of Commerce, Community, and Economic Development proposes to adopt regulation changes in Title 3, Chapter 8 of the Alaska Administrative Code, dealing with solicitations of proxies for corporations organized under ANCSA and repealing obsolete or reorganized provisions, including the following:

- (1) <u>3 AAC 08.300, .310, .320, .322, .324, and .330</u> are proposed to be repealed in accordance with changes made by the Legislature in 2019 that relocated state securities statutes from AS 45.55 to AS 45.56. Accordingly, securities regulations under 3 AAC 08 are proposed to be repealed from 3 AAC 08 in these regulations so they can be adopted under 3 AAC 09 in another department regulations project.
- (2) <u>3 AAC 08.307</u> is proposed to be repealed and readopted to clarify requirements related to filing material related to a proxy solicitation with the administrator and to remove dated electronic format and medium filing requirements.
- (3) <u>3 AAC 08.345(b)(1)(G) and .355(4)(G)</u> are proposed to be repealed and readopted to update the list of events that must be described in a report for a nominee, if the event occurred in the last ten years, for a solicitation of proxies on behalf of a board or on behalf of a non-board participant in connection with an action that is to be taken on the election of a director to include a violation of AS 45.55 (Alaska Native Claims Settlement Act Corporations Proxy Solicitations and Stock Act).
- (4) <u>3 AAC 08.365</u> is proposed to be amended at paragraphs (11) and (16) to clarify the meaning of the terms "participant" and "solicit[ation]," respectively.
- (5) 3 AAC 08.920(c) is proposed to be repealed to conform to state law.

The language of the final regulation may be different from that of the proposed regulation. You should comment during the time allowed if your interests could be affected.

Upon written request, the administrator may waive the electronic filing requirement and allow for an alternate filing method.
- (b) An annual report, proxy, consent or authorization, proxy statement, or other material relating to proxy solicitation is filed under AS 45.55.139 when the administrator receives it, unless the administrator rejects it under (c) of this section.
- (c) The administrator may reject a filing if it is not required to be filed under AS 45.55.139, contains personal information, or is illegible or corrupt. If a filing is rejected, it may be corrected and resubmitted to the administrator. In this subsection, "personal information" has the meaning given in AS 45.48.090.
