Respondents have engaged in the offer and sale of a partnership offering (Federal Reg. D Rule 504) known as Southwest Eldorado Prospect #1 in the State of Alaska without benefit of proper registration under terms and conditions of the Alaska Securities Act. Offer was made to Mr. Lawrence Summers of 8809 Iowa Drive, Anchorage, Alaska 99517 on or about June 27, 1994.

Respondent, Robo Enterprises, was advised by the division in correspondence dated May 5, 1993 (attached herewith as Exhibit "A") that such offers were subject to registration and could not be made without an order of effectiveness.

Whereas, the parties are desirous of settling this matter in an expeditious manner, the undersigned agree as follows:

Respondents agree to not offer or sell any securities in this jurisdiction without proper registration and further agree that they will make no registration submissions to the State of Alaska for consideration for a period of two years from the date of execution of the consent agreement.

Respondents agree to tender herewith in accord with the terms of AS 45.55.200 a civil fine in the amount of \$1,500.00 to defray the division's costs in investigating and adjudicating this matter.

Plaintiff agrees to vacate proposed cease and desist order in lieu of this voluntary consent decree. Respondents are advised that by accepting the conditions of consent agreement, they waive the right to a hearing on this matter as is provided under AS 45.55.200 had a cease and desist order been issued. Respondents may request a hearing relative to the terms and conditions imposed under this consent agreement. Absent any such request for hearing this agreement shall remain full force and binding on the parties until it is amended or vacated by further order of the administrator.

In agreeing to the foregoing, Respondents neither admit nor deny any of the allegation brought to Plaintiff.
