PETITION BY THE CITY OF AKUTAN, A CITY WITHIN THE ALEUTIANS EAST BOROUGH, FOR ANNEXATION BY ELECTION OF APPROXIMATELY 52 SQUARE MILES OF UNINHABITED TERRITORY

The Petitioner hereby requests the Alaska Local Boundary Commission to approve this petition for annexation pursuant to Article X, Section 12 of the Constitution of the State of Alaska and AS 29.06.040(a) and (c), 3 AAC 110.600(c). All Exhibits attached to this petition are incorporated by reference.

Section 1. PETITIONER. The name and class of the city petitioning for annexation are listed below:

Name: City of Akutan Class: Second Class

Section 2. GENERAL DESCRIPTION OF THE TERRITORY PROPOSED FOR ANNEXATION. The territory proposed for annexation is generally described as follows:

An estimated 54.35 square miles comprised of 32.17 square miles of lands and 22.18 square miles of tidelands and submerged lands, the uplands on the northern and southern side of Akutan Harbor along with the uplands west of the city boundaries and waters east of the existing boundaries. The new city boundaries would encompass approximately 70 square miles.

Section 3. REASONS FOR ANNEXATION. The City seeks to annex the territory in question for the following reasons:

- Eventual development of an on-land airport and a geothermal project that directly rely on city services. Both projects are located outside of the current city boundaries.
 - A. The Aleutians East Borough and the City of Akutan have worked closely with state and federal officials to construct an onshore airport facility in Akutan. The community is one of the few places in Alaska without airport or airstrip. As indicated on the map, the location of the proposed airport is outside of the current city boundaries. Per the most recent federal highway bill, \$3 million has been allocated for construction of a road to the airport site. (*Anchorage Daily News*, March 25, 2004). Construction of the site is slated for 2005-06. Upon arrival in Akutan, air passengers will then either travel via road or road and ferry to the community or adjacent fish processing plant. Trident Seafoods is a key user of the facility with as many as 800 workers traveling in and out of Akutan over the various fishing seasons.

Section 9. POPULATION. The population within the current boundaries of the City is estimated to be: 787. The population of the territory proposed for annexation is estimated to be: **zero**.

Since such services are provided outside the current municipal boundaries, the city is subject to some legal exposure since its insurance policy does not cover such activities.

EXHIBIT G TRANSITION PLAN

The city transition plan is fairly straightforward. Key services such as planning, emergency health care and public safety will be extended to annexed area within the first year of the annexation. This will mean an internal assessment of current city capacity to provide such services in the proposed annexed area. The initial city assessment is that a limited expansion of the three core services will be required. The budget for such services (as noted in section 16) will entail annual expenses of \$30,000-40,000. The specific details of whether additional equipment, facilities and vehicles will be made upon annexation of the additional territory. It is expected that the city will be purchase an emergency medical vehicle along with needed medical supplies and equipment for emergency health care along with a public safety vehicle for the newly annexed area.

EXHIBIT H VOTING RIGHTS ACT REVIEW

There is no Federal Voting Rights Act impact on the area to be annexed.

EXHIBIT I PETITIONER'S BRIEF

The provisions of 3 AAC 110.420(b)(18) require, "a supporting brief that provides a detailed explanation of how the proposal satisfies each constitutional, statutory, and regulatory standard that is relevant to the proposed commission action." The standards are summarized as follows:

- A. Based on relevant factors listed in 3 AAC 110.090(a), plus other relevant factors, the territory proposed for annexation exhibits a reasonable need for city government.
 - Per 3AAC 110.090 (a) (2-4) the city expects the development of a municipal operated airport and linking road system outside the current municipal boundaries. Moreover, the city expects exploration and possible development of a geothermal energy project adjacent to the current city boundaries. To meet the needs of the new territory and the residents of the city, the city seeks to annex adjacent lands and in turn provide emergency medical, public safety and planning services to such territories.
- B. In accordance with 3 AAC 110.090(b), services determined to be essential city services under 3 AAC 110.970 can be provided more efficiently and more effectively by the City (Petitioner) than by another existing city or by an organized borough on an areawide basis or non-areawide basis, or through an existing borough service area.
 - The city is the only governmental entity that would provide such services in the Aleutians East Borough.
- C. Based on relevant factors listed in 3 AAC 110.100, plus other relevant factors, the territory proposed for annexation is compatible in character with the annexing city.
 - The territory proposed for annexation is unpopulated. It is nonetheless suitable for reasonably anticipated community purposes (i.e. airport roads and a possible geothermal energy project).
- D. Based on relevant factors listed in 3 AAC 110.110, plus other relevant factors, the economy within the proposed expanded boundaries of the City include the human and financial resources necessary to provide services determined to be essential city services under 3 AAC 110.970 on an efficient, cost-effective level.

The territory proposed for annexation is unpopulated. The city is financially capable of providing the needed services within its current budget. The city is not anticipating additional derived from the annexed territory.

E. Based on relevant factors listed in 3 AAC 110.120, plus other relevant factors, the population within the proposed expanded boundaries of the City are sufficiently large and stable to support the extension of city government.

The territory proposed for annexation is unpopulated. It is not expected that the area will result in new residents.

F. Based on relevant factors listed in 3 AAC 110.130(a), plus other relevant factors, the proposed expanded boundaries of the city include all land and water necessary to provide the full development of services determined to be essential city services under 3 AAC 110.970 on an efficient, cost-effective level.

The area proposed is owned by the Akutan Corporation. The land is essentially vacant and used only sporadically for subsistence purposes.

G. The territory proposed for annexation is contiguous to the existing boundaries of the City and would not create enclaves in the expanded boundaries of the City. Alternatively, under 3 AAC 110.130(b), a specific and persuasive showing is made that annexation of noncontiguous territory or territory that would create enclaves includes all land and water necessary to allow, on an efficient, cost-effective level, the full development of services determined to be essential city services under 3 AAC 110.970.

The territory proposed for annexation is contiguous to the existing boundaries of the city and would not create enclave in the expanded boundaries of the City.

H. Under 3 AAC 110.130(c), the proposed expanded boundaries of the City include only that territory comprising an existing local community, plus reasonably predictable growth, development, and public safety needs during the 10 years following the effective date of annexation.

The proposed expanded boundaries of the City include only that territory comprising the City of Akutan plus reasonably predictable growth, development, and public safety needs during the 10 years following the effective date of the annexation.

I. Under 3 AAC 110.130(d), the proposed expanded boundaries of the City do not include entire geographical regions or large unpopulated areas, except

where justified by the application of the standards in 3 AAC 110.090 - 3 AAC 110.135.

Although the territory includes somewhat large unpopulated areas, the areas identified are essential for the expansion of the road, development of the airport and the potential geothermal project.

J. If the Petition describes boundaries overlapping the boundaries of an existing organized borough, the Petition addresses the procedures and the brief addresses the standards for either annexation of the enlarged city to the existing organized borough, or detachment of the enlarged city from the existing organized borough. K. Based on relevant factors listed in 3 AAC 110.135, plus other relevant factors, annexation to the City is in the best interests of the state under AS 29.06.040(a) and 3 AAC 110.980.

Annexation of the proposed areas will promote maximum local self-government by the city logically, legally and thoughtfully extending its boundaries to provide needed basic services. As the only local provider of such services it will relieve the state government of such responsibility.

L. The territory proposed for annexation meets the annexation standards specified in 3 AAC 110.090 - 3 AAC 110.135. Although the annexation proposal is not subject to the legislative-review annexation standard set out in 3 AAC 110.140, the brief also demonstrates with detailed facts and analysis any of the circumstances outlined in 3 AAC 110.140(1) – (9) that exist with respect to the annexation proposal.

Under 3AAC 110.140 (2) annexation of the proposed territory will allow the city to legally and safely provide emergency medical, public safety and planning services. This will enable the city to regulate and control the detrimental effects of the construction and operation of an airport road and field and possible geothermal power development project.

M. Annexation is subject to approval by a majority of voters who vote on the question within the annexing municipality, as provided in 3 AAC 110.150(5).

The territory proposed for annexation is unpopulated.

N. In accordance with 3 AAC 110.910, the proposed annexation to the City will not deny any person the enjoyment of any civil or political right, including voting rights, because of race, color, creed, sex, or national origin.

The city annexation would comply with all such provisions.

O. The Petitioner has prepared a proper transition plan under 3 AAC 110.900.

Other constitutional principles served by the annexation proposal, such as the equal-protection clause and the equal-responsibility clause of Article I, Section 1, of the Constitution of the State of Alaska and the maximum local self-government clause and minimum of local government units clause of Article X, Section 1, of the Constitution of the State of Alaska are also addressed in the supporting brief.

The city has prepared a transition plan as part of this document.
